### The Property

This beautifully presented apartment occupies the hall and partial first floor of a fine Grade II listed building on the iconic and much sought after Royal York Crescent. The well-proportioned accommodation is conveniently located off a central hallway. To the front of the property is a grand sitting room with classic Georgian proportions and southerly views towards the treeline of the extensive residents' communal garden, this lovely room further benefits from a feature fireplace, storage cupboard and high ceilings, affording plenty of space for both seating and dining. The recently enhanced, semi open plan contemporary kitchen with a range of modern units, granite worksurfaces, contemporary lighting and attractive breakfast bar is situated off the hallway. A modern bathroom with three-piece white suite with mains fed shower is also situated off this internal area. To the rear of the property, one at hall floor level and one approached via a short flight of stairs, are two good sized double bedrooms, benefitting from large sash windows. The first-floor bedroom further benefits from an attractive en-suite shower room, with basin, low level WC and large walk-in shower cubicle.

### Location

Clifton and the surrounding areas, with its Victorian and Georgian architecture, are amongst the most sought after locations in the City. The area offers charm alongside excellent amenities with independent shops, boutiques, cafes, bars and restaurants to be found on both Whiteladies Road and Clifton Village including Clifton Down shopping Centre. The Downs offers four hundred acres of green public space whilst Brunel's Clifton Suspension Bridge provides a gateway to the Ashton Court Estate with its woodlands, mountain bike trails and walks whilst there is excellent access to the exciting Harbourside district, the City Centre and Temple Meads.
