The Property

Occupying the end of this pretty period terrace, this charming one bedroom hall floor flat is tucked down a quiet cobbled street in the heart of Clifton Village.

Well located to take advantage of the huge array of local amenities the property is perfectly suited to first time buyers or investors alike.

Internally, the property has been beautifully presented and the living room benefits from high ceilings, a large sash window as well as stripped wooden floorboards.

The modern kitchen is open to the living space and provides plenty of storage space in a range of fitted white wall and base units stylishly finished with solid wood work tops and tiled surrounds as well as breakfast bar.

The bedroom is generously proportioned and offers built in wardrobes as well as pretty sash window providing a quiet and pleasant outlook out over the rear.

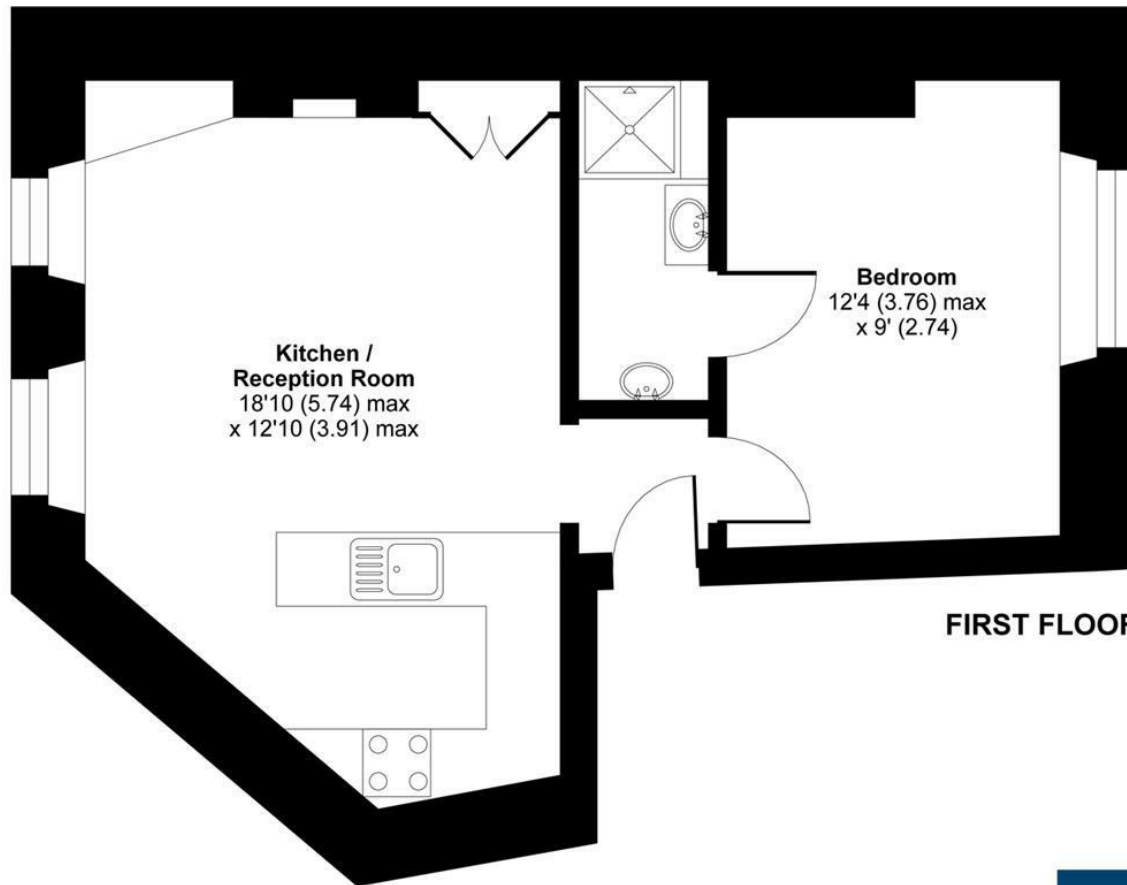
