The Property

A characterful apartment set on the first floor of this Gothic style former church hall which was converted into a number of apartments in the late 80's.

The living space is located at the rear of the building and, via double doors, enjoys direct access to a private spacious courtyard garden as well as a pleasant outlook over the immaculately presented church gardens which residents of the block have quiet enjoyment of.

Adjacent there is a separate kitchen which provides a good amount of cupboard and worktop space along with gas hob with extractor over and oven, a stainless steel sink, integrated dishwasher and plumbing for washing machine.

The bedroom is a good sized space and also has the added benefit of a large built in wardrobe / cupboard.

Finally there is a bathroom which offers a mains fed shower over bath, basin, WC as well as a separate storage cupboard.

In addition there is another cupboard off the hallway and the residents of the building have quiet enjoyment and access to the church gardens as well as an allocated parking space.

Location

Clifton and the surrounding areas, with its Victorian and Georgian architecture, are amongst the most sought after locations in the City. The area offers charm alongside excellent amenities with independent shops, boutiques, cafes, bars and restaurants to be found on both Whiteladies Road and Clifton Village including Clifton Down shopping Centre. 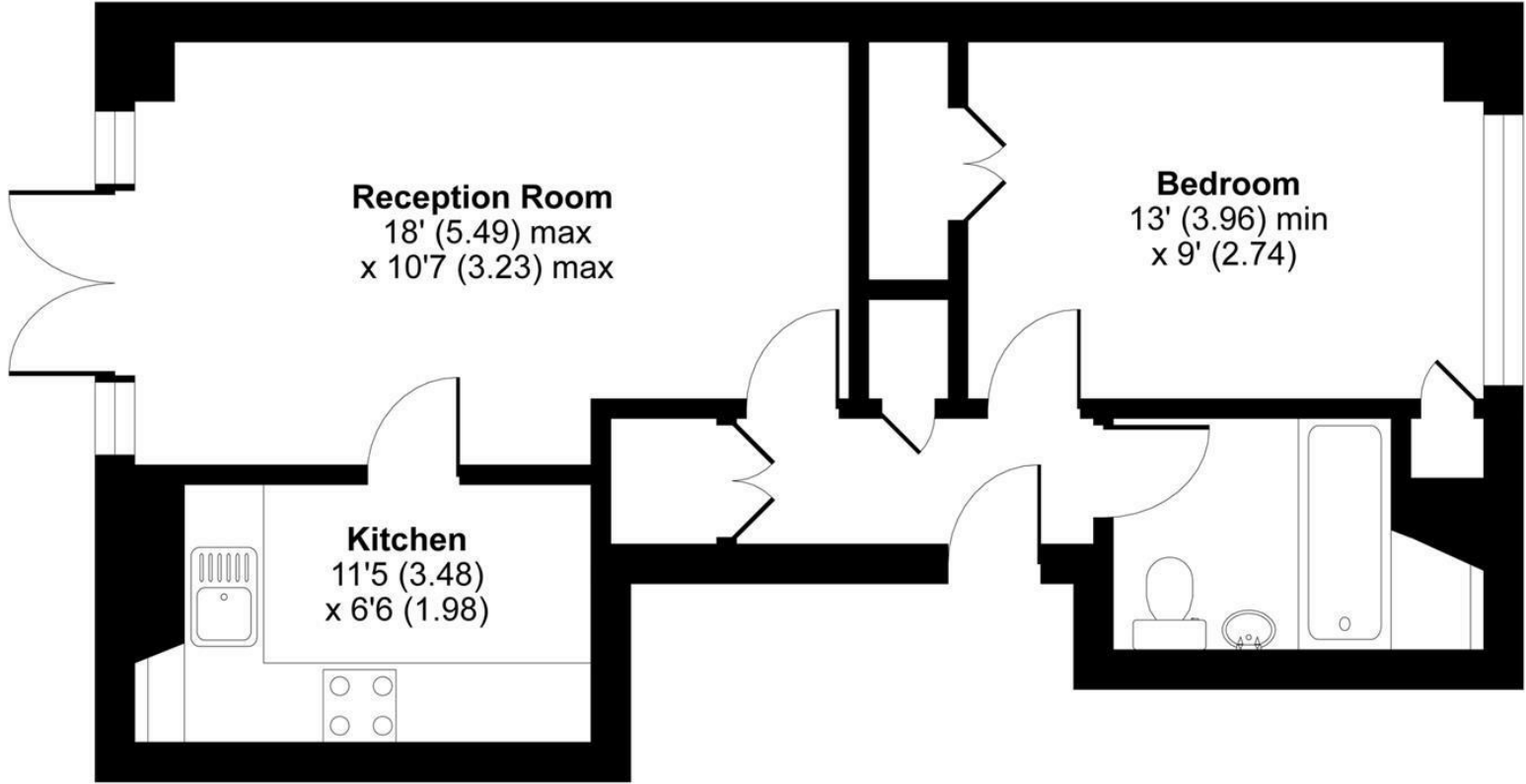
