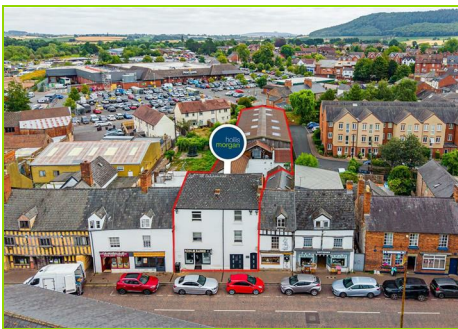

GUIDE PRICE

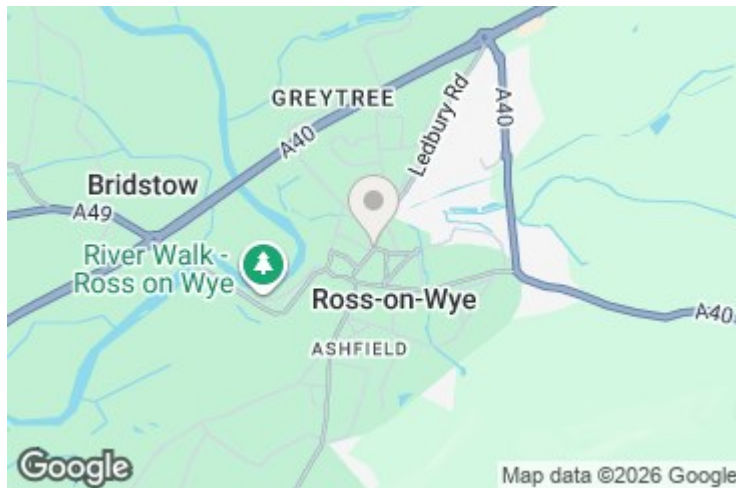

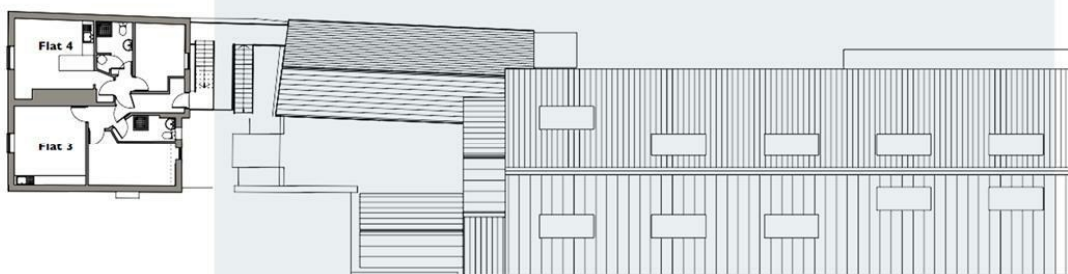
2026 CHARITY OF THE YEAR

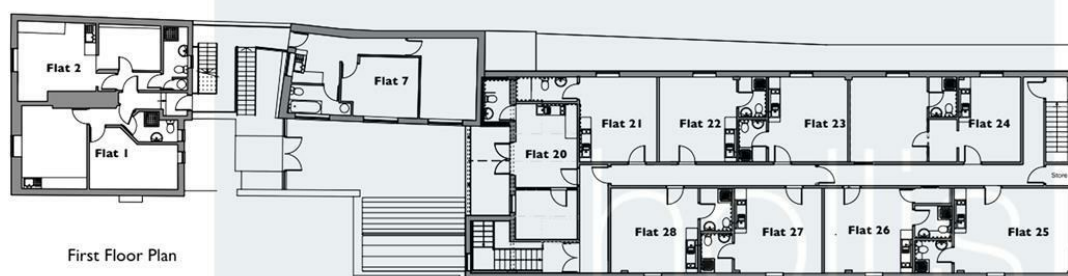

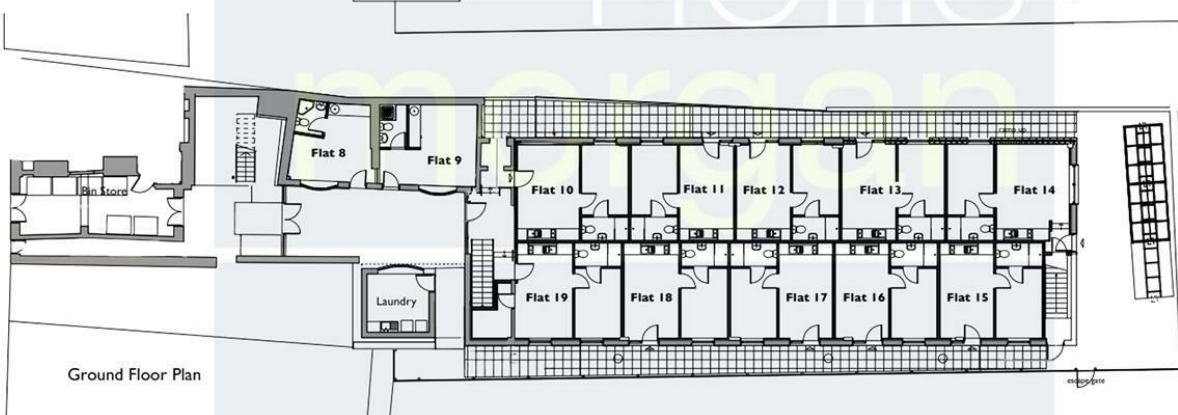




Second Floor Plan
