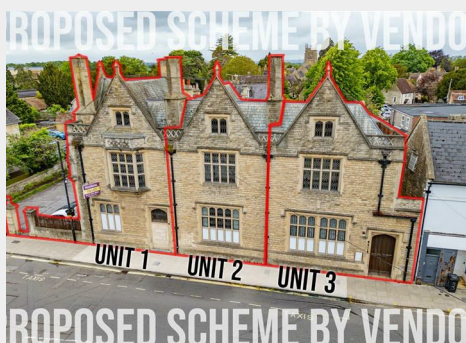

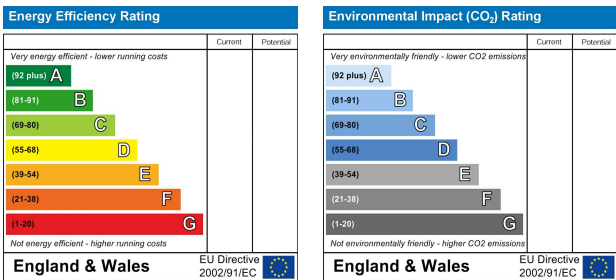
The property was a High Street bank for many years and would suit a range of commercial uses either as 1 large unit or split into multiple units
