Hallway

Entering via a front porch into the main hallway with stairs to the first floor, doorways to the lounge and kitchen, under-stairs cupboards, fitted carpets.

Lounge 4.23 x 3.14m (13'11 x 10'4)

Generous lounge with window to the rear aspect, TV

points, fitted carpets.

Dining Room 3.80 x 3.065m (12'8 x 10'0)

Good size dining room which is open plan to the adjacent kitchen, sliding doors to the rear aspect.

Fitted kitchen with a range of eye and base level cupboards, integrated electric hob with extractor over, integrated electric oven, window to the front aspect, opening to the adjacent dining room, side door to the utility room which has plumbing for washing machine and door to the front garden, wall mounted gas boiler.
