



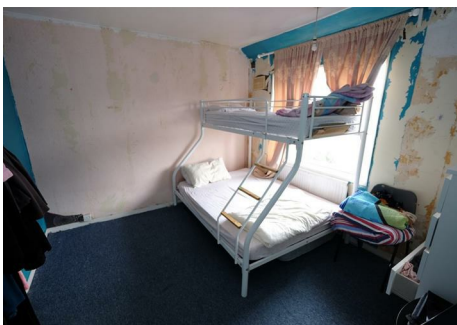
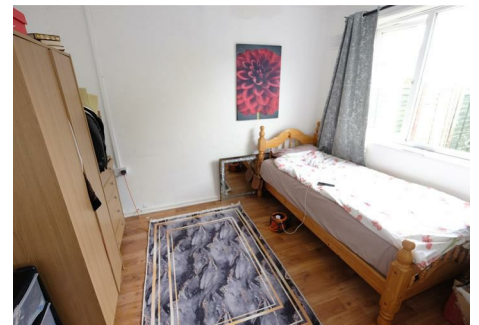
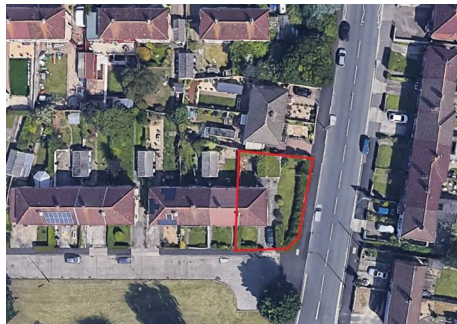

The property is situated on a quiet residential road the suburb of Southmead. A wide range of local amenities are available on Southmead Road and Lidl supermarket are close by.

The property has been let for many years and would now benefit from basic updating to create a fine home or investment in this increasingly sought after location.

Given the size of the corner plot there is scope to extend the property to create flats or a larger HMO style investment property.

GUIDE PRICE
