LOCATION

Stillhouse Lane is a quiet and quirky cobblestone street much changed in recent years within walking distance of East street - a popular pedestrianised High Street with a wide range of retailers and traders serving the local area, yet within one mile of the City Centre and close to North Street.

THE OPPORTUNITY

REQUIRES MODERNISATION

The property is sold vacant and in need of modernisation.

We are informed the roof has been felt and battened (April 2020) and new valleys replaced and new tiles installed at a cost of £8,500.

7 BED HMO - SCOPE FOR £58,800 PA

The property has scope for conversion into a 7 bed HMO subject to consents.

LARGE FAMILY HOME

The property offers the rare chance for a large family home with garden in BS3 within walking distance of the

City Centre.

The majority of the housing options in the area are approximately 1/3 smaller than Glenthorne.

There is scope to convert the property into flats.
