A Freehold detached commercial property ( 1364 Sq Ft ) occupying a unique maritime position on the Pump Square in Pill overlooking the River Avon with views towards the Bristol Channel and across to Shirehampton. The property is offered with vacant possession but has most recently been used as the clubhouse for Portishead Cruising Club, an RYA affiliated sailing club for racing & cruising yachts. The accommodation has its primary entrance at ground floor level with a secondary fire escape direct to the first floor. The accommodation comprises bathrooms and ancillary space on the ground floor whilst the first floor is a large open plan bar / function room with fitted bar and kitchen area.

### PLANNING

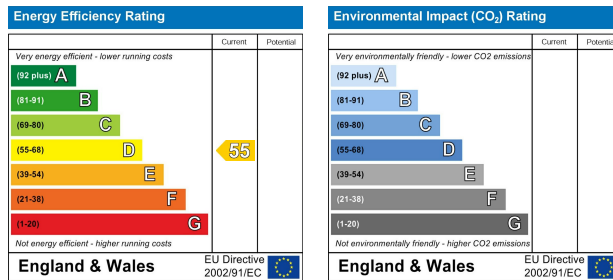

Planning was previously granted ( 24/P/0330/FUL ) to remove the restrictions on the property being solely used by Portishead Sailing club. Please note as part of the consent time and noise restrictions were included but are currently being appealed ( we do not foresee a conclusion to this appeal prior to the sale )
