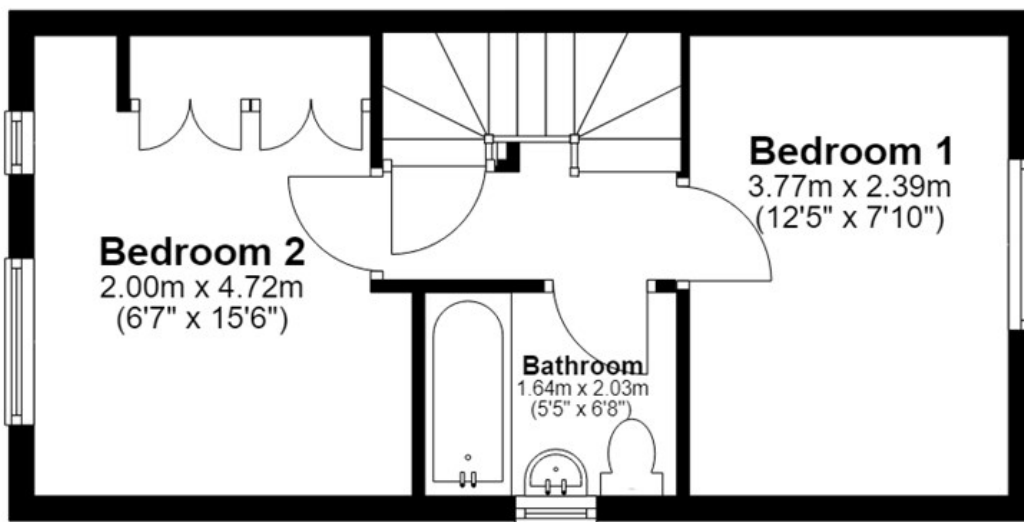
Ground Floor
