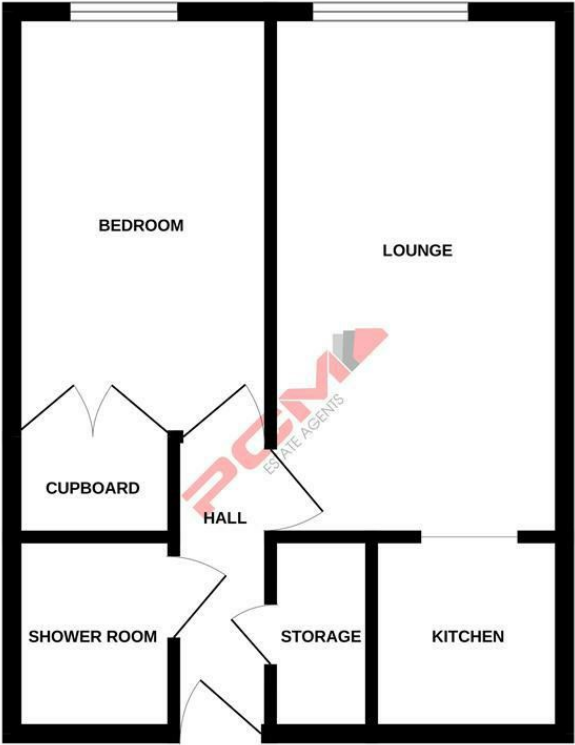

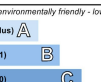
GROUND FLOOR
