Ideally positioned approximately one mile from Henley-on-Thames and offering excellent access to London and the surrounding areas, Rose Cottage is a delightful period home full of character. Arranged over three floors, the property provides versatile accommodation with the option of three to four bedrooms, two to three reception rooms, and the added benefit of private parking for two cars and a pretty low-maintenance cottage garden. The location offers a perfect balance of countryside living and urban convenience. Commuters benefit from easy access to the M4 (Junction 8/9 at Maidenhead) and M40 (Junction 4 at High Wycombe), with Maidenhead Station providing direct services to London Paddington and Elizabeth Line connections, and Henley branch line connects with Twyford.

Phyllis Court Country Club is located on the river on the outskirts of Henley centre opposite Henley Rugby Club..

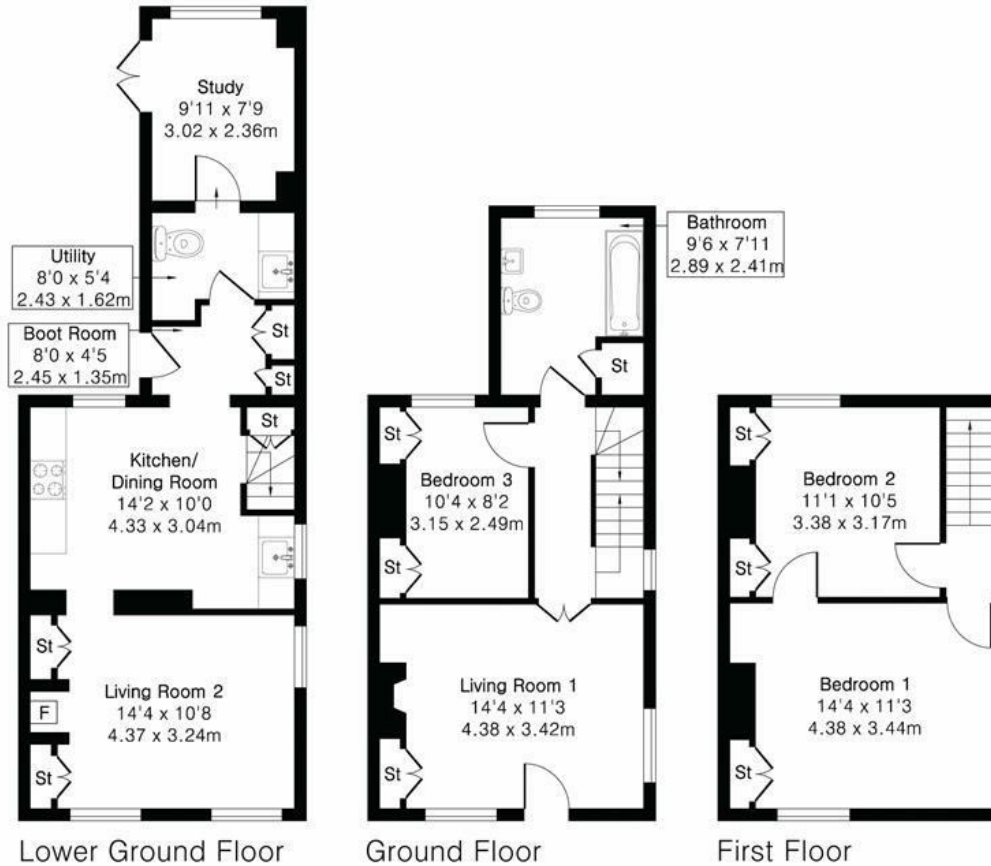
