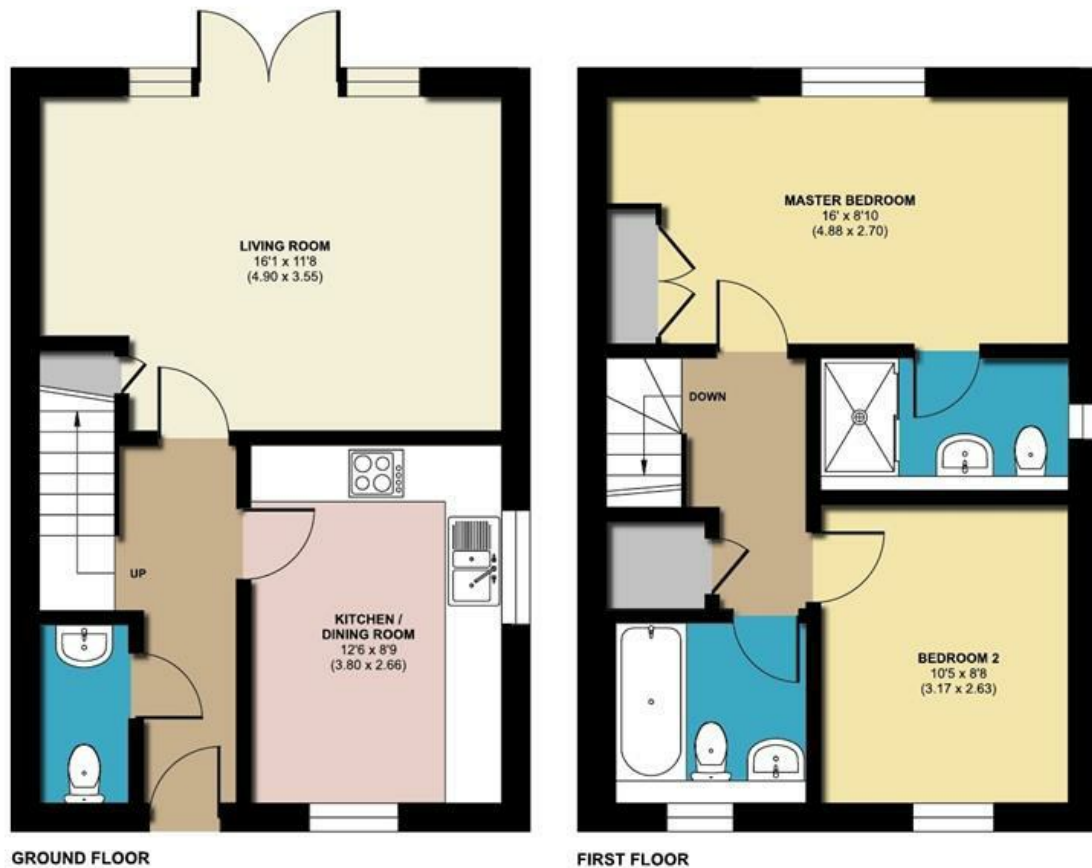




Woodlark Way, Finchwood Park, Wokingham
