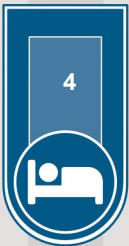

The location

Wimbledon Hill Park is the development of the former Atkinson Morley Hospital site off Copse Hill, offering a variety of exceptional houses and luxury apartments created by Berkeley Homes. Wimbledon Village is approximately a mile away, with its collection of delightful shops and restaurants. Wimbledon Common with its 1,200 acres of open space is around 800 metres away and approaches the Village to create a sense of country living within London. Central London can be reached via the A3 or by rail from Wimbledon mainline or Raynes Park, both accessed via the regular 200 bus route on Copse Hill. Locally are a number of excellent schools with The Rowans pre prep school 150 metres away and the highly sought after Kings College School close-by. Morley Park is adjacent to this development and Cottenham Park is around 350 metres away with a playground and sports ground.



The Property

Atkinson House forms part of the luxury Berkeley Homes development, Wimbledon Hill Park. There are beautifully maintained landscaped communal gardens, a cinema room, gym, concierge and underground parking. This superb duplex apartment comprises an elegant reception room with wooden flooring, feature lighting and full height windows allowing an abundance of natural light and green views. The reception room opens on to a decked, south facing balcony, perfect for dining and relaxing. A stunning contemporary kitchen with a breakfast bar. is located off the reception space and features beautiful cabinetry and a range of fitted units with stone work surfaces, Miele appliances with 4 ovens including steam oven. Siemens fridge and separate freezer. Also on this level there is a double bedroom, guest shower room and a fourth bedroom/study. An easy rising staircase leads to the upper level which provides initially a study/snug area and then access to the principal bedroom suite with fitted wardrobes and a generous en suite bathroom. There is another en suite double bedroom. The principal bedroom and the living room have comfort cooling. The property benefits from two allocated spaces in the underground parking area.
