Modern terraced house with off-road parking for two cars and a good size, fully enclosed rear garden situated in a quiet cul-de-sac within a popular residential area of Stamford.

Integrated appliances comprise Indesit electric oven and Hotpoint gas hob with extractor hood above.

There is an undercounter space and plumbing for a

washing machine and space for upright fridge-freezer.

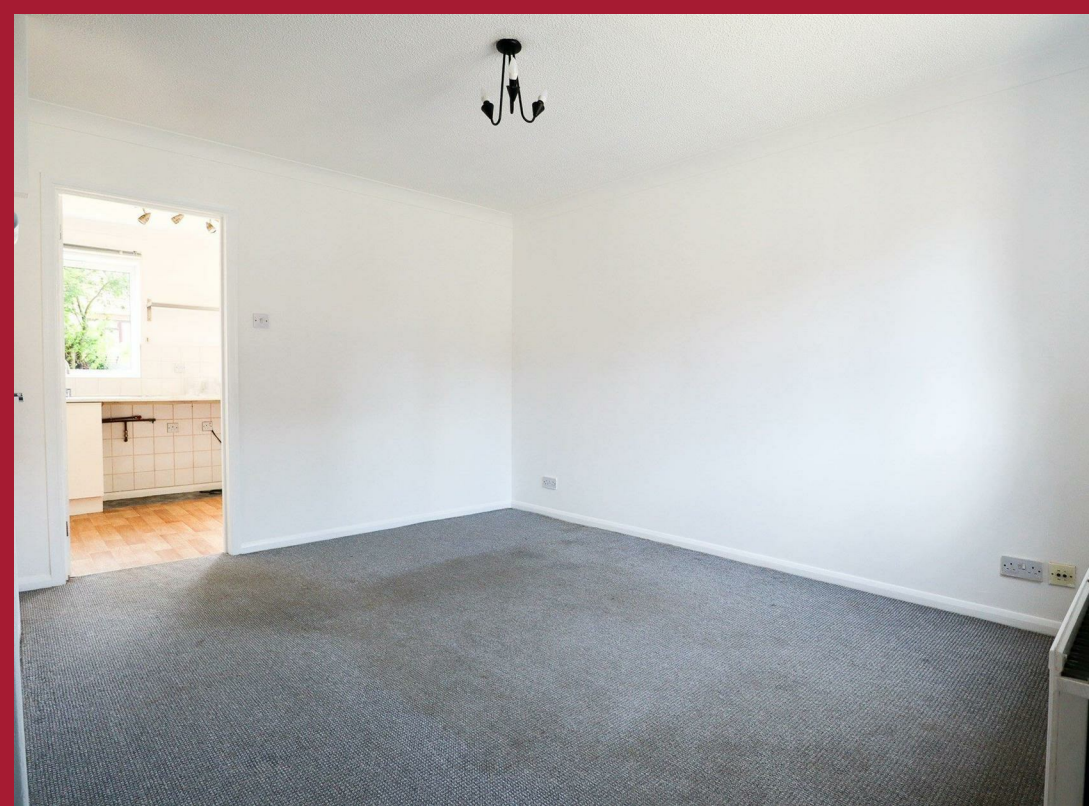

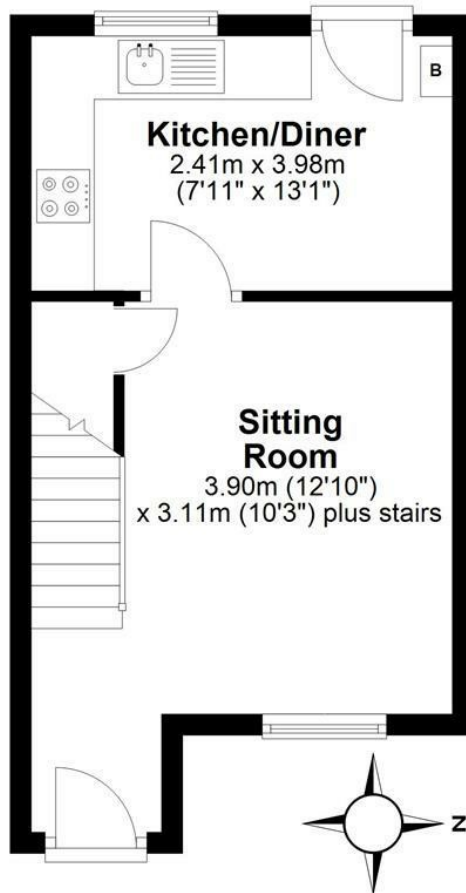

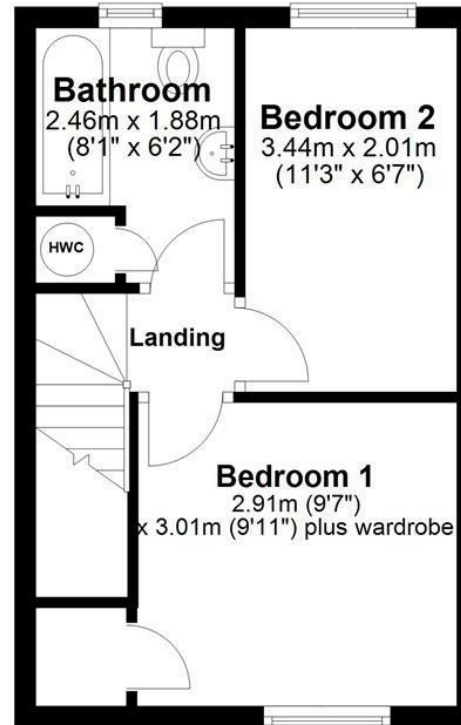
### Ground Floor
