Conveniently positioned for York city centre, railway station, York District Hospital and local schools, Cocoa Gardens has been designed and constructed by Latimer, part of Clarion Housing Group. The development combines modern design with energy-efficient features, including air source heat pumps.

The property opens into a welcoming entrance hall leading to a superb open-plan kitchen, living and dining room. With windows to three elevations, the space is filled with natural light. The contemporary kitchen features integrated Bosch appliances, including a fan oven, microwave and induction hob, with Amtico flooring throughout the ground floor.

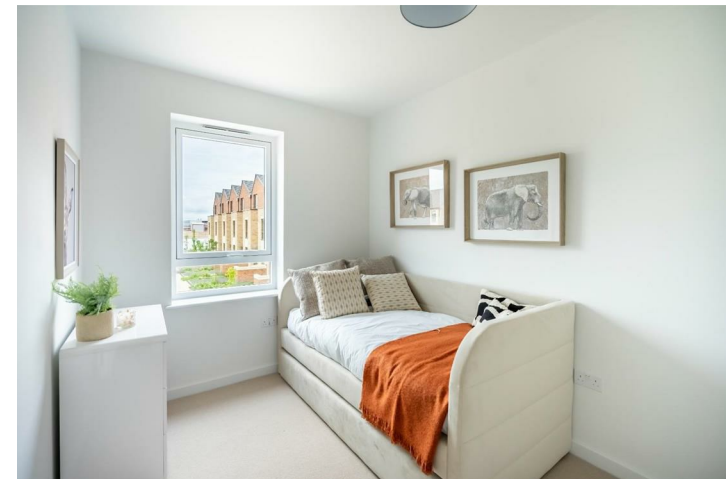
The living and dining area overlooks the south-facing garden and benefits from French doors opening outside. The garden includes a paved patio and shed, while two storage cupboards and a ground-floor cloakroom add practicality.

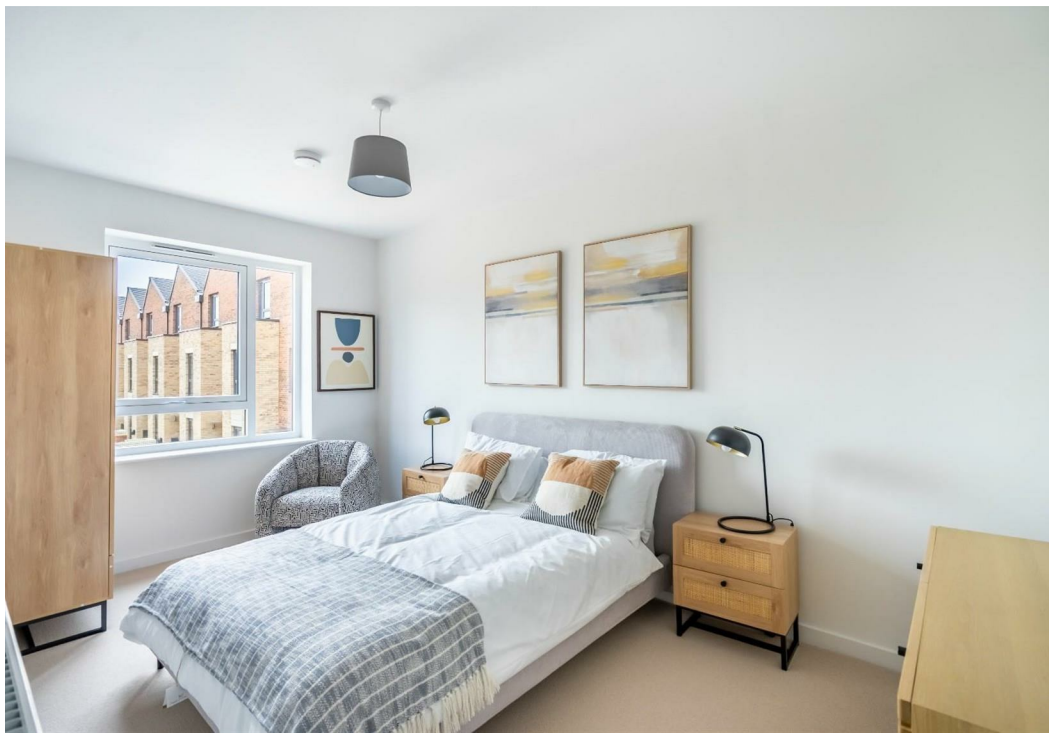
Upstairs are three generous double bedrooms, with the principal bedroom benefiting from a contemporary en-suite shower room. The family bathroom features Vitra sanitaryware, Vado brassware and a bath with rainfall and handheld showers.

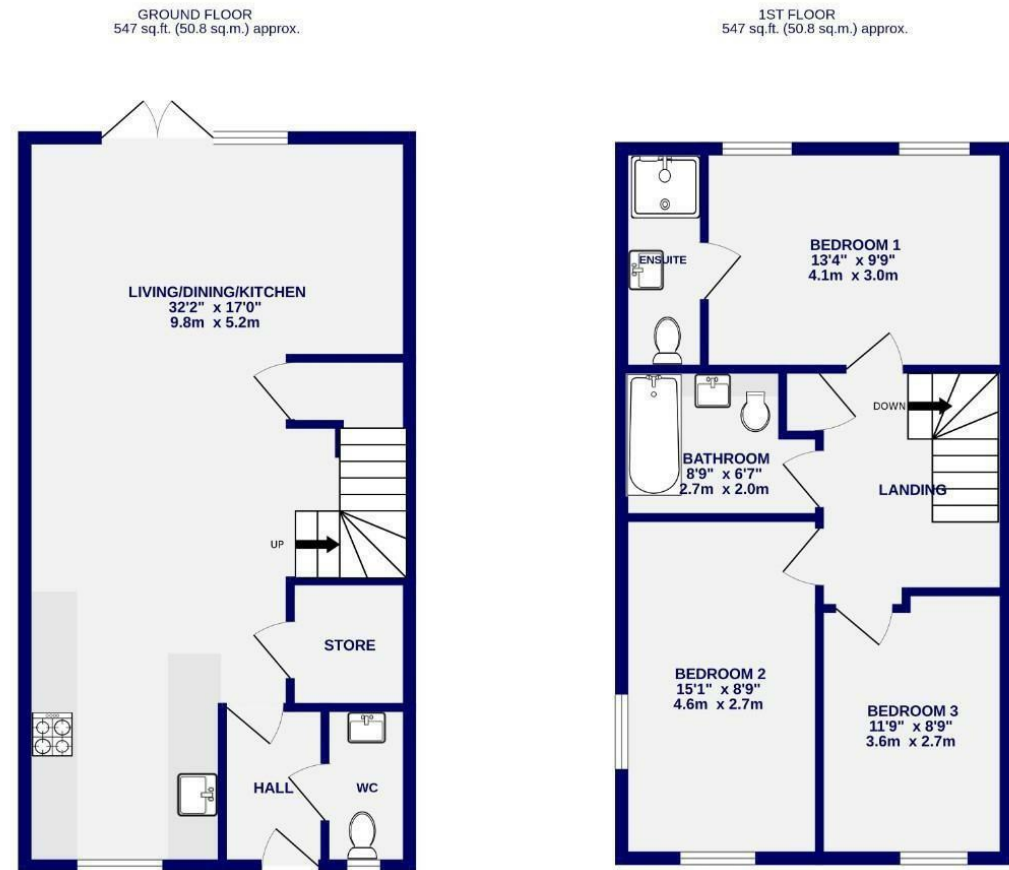
