The accommodation comprises:- Entrance with stairs off, lounge diner, kitchen, first floor landing, three bedrooms and bathroom. Small garden areas with off set parking area. Gas fired central heating system (not tested) and double glazing. Viewing via Leonards.

## Location

The village of Sutton lies just inside Kingston Upon Hull boundary, approximately three and a half miles north East of the City Centre. The village has a few local shops and amenities. There are local primary and secondary schools nearby and the village offers good road access via the outer ring road to the Ennerdale link road to areas such as Beverley and York and via Hedon Road to the A63.

Main front entrance door provides access into the property. Stairs lead off to the first floor accommodation with under stairs cupboard. Radiator. Access into ground floor rooms off.

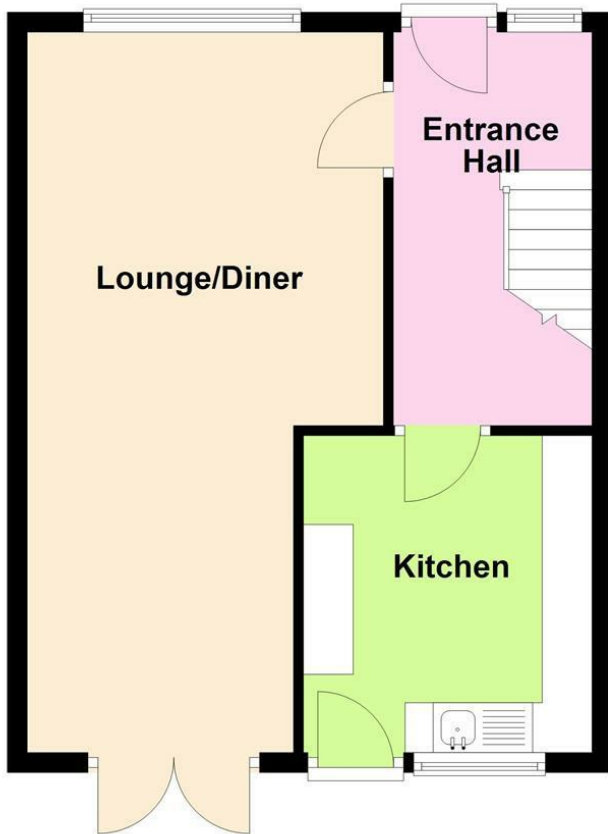

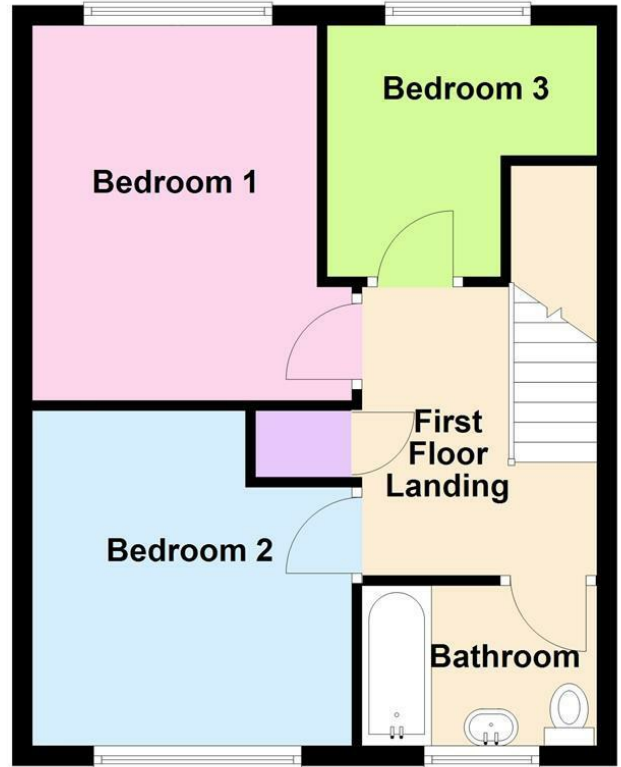

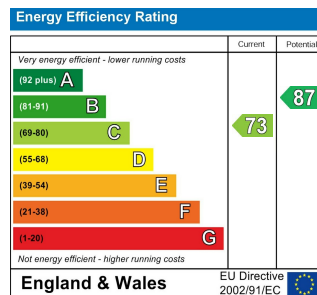
