Three bedroom semi detached house. Offered for sale with No Forward Chain. The property would benefit from some enhancement and comprises:- Entrance lobby, hallway, lounge, dining kitchen, first floor landing, three bedrooms and bathroom. Garden areas with off road parking and single garage and additional store area. Gas fired central heating system and double glazing. Viewing via Leonards.

Location

The Historic Town of Hedon is located just off the A1033, approximately seven miles to the east of the centre of Hull. Considered as the Gateway to Holderness, Hedon also serves many of the nearby villages and has a variety of local shops and educational facilities.

Entrance Lobby

Main front entrance door provides access into the property. Inner door leads into:




Ground Floor
