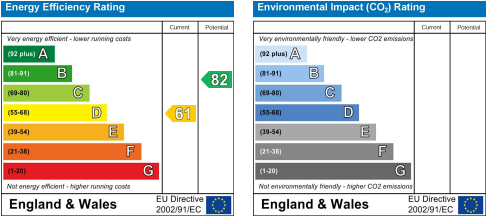


Floor Plan
