Absolutely charming ground floor period apartment, situated a short walk away from the city centre and with schooling all within walking distance. The property is fully renovated and modern throughout yet retains some nice period features in keeping with the age. The property has well maintained communal gardens and drying green to the rear with shared outhouse for outdoor storage. The accommodation is beautifully presented and briefly comprises reception hall, lounge, fitted modern kitchen, two generous double bedrooms and storage, together with stylish bathroom and overhead shower. There is additional under stair storage in the communal entrance. The property is double glazed with gas central heating.





LOCATION

The ancient capital of Dunfermline won its bid to have official city status in May 2022, as part of the civic honour's competition to celebrate the Queen's platinum jubilee. The City of Dunfermline is of considerable historic interest and is the resting place of King Robert the Bruce. Carnegie's Birthplace museum, the Abbey and Abbot House reflect the historic interest of the city, whilst recent developments have seen Dunfermline move into the modern era with Carnegie Museum and Library. Dunfermline is located approximately five miles from the Forth bridges and is therefore particularly popular with commuters to Edinburgh and many parts of the central belt with easy access to the M90 motorway with its direct links to Edinburgh, Perth and Dundee and across the Kincardine Bridge by way of motorways to Stirling, Glasgow and the West. It benefits from a full range of shops, social and leisure facilities and educational establishments. The local railway stations provide a regular service to Edinburgh with intercity links to other parts of the UK. There are regular and convenient bus services both local and national.

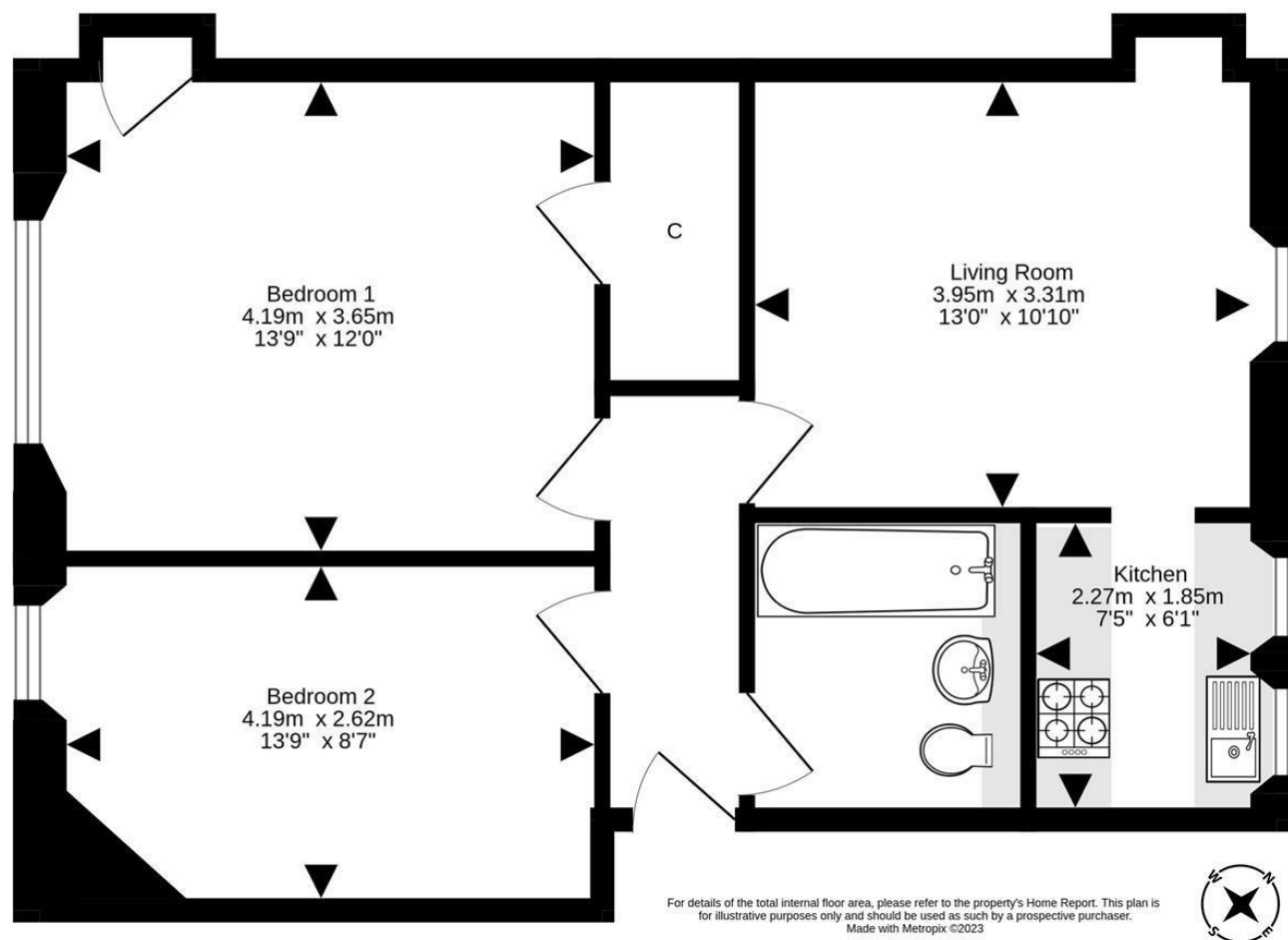
