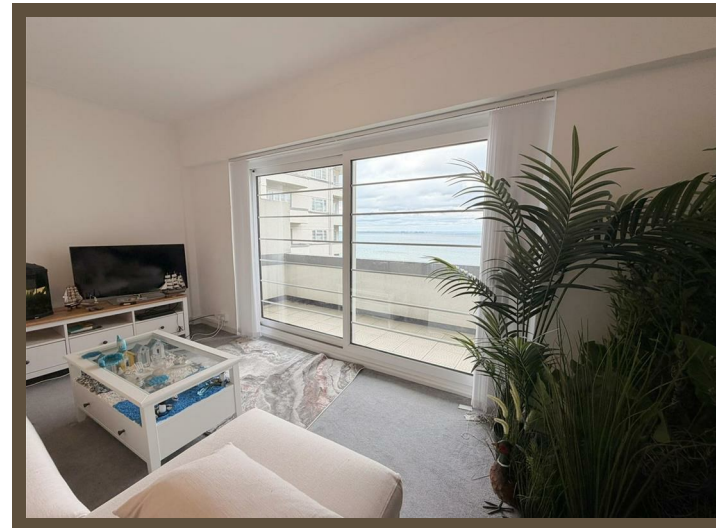

Large welcoming entrance with 2 large storage cupboards. Radiator. Doors to all rooms.

Lounge/diner

Large, bright room with UPVC double glazed patio doors to front leading to balcony and with superb estuary views. Radiator, coved ceiling.

Balcony

South facing balcony with uninterrupted estuary views. Ample space for sun beds or outside dining area. Outside light.

UPVC double glazed window to rear. Obscure glazed door leading to fire escape. Range of white, high gloss base & eye level units with matching drawer pack. Integrated electric double oven, separate gas hob, extractor fan & fridge/freezer. Space for washing machine. Roll edge worktops with inset stainless steel sink unit with matching drainer & mixer tap, tiled splashbacks.

Master bedroom

Huge room with large UPVC double glazed window to front with sea views. Large built in cupboards, radiators, coved ceiling.

Obscure UPVC double glazed window to rear. Shower cubicle, fully tiled walls.

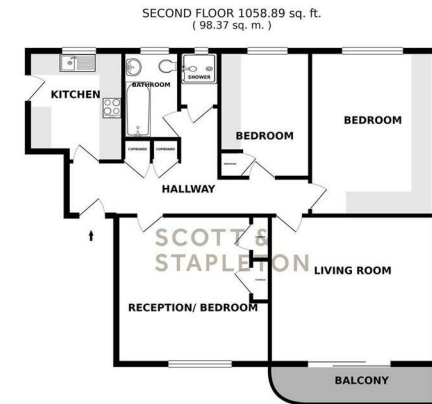
The property is surrounded by well tended communal gardens with a large area to the front overlooking the estuary.
