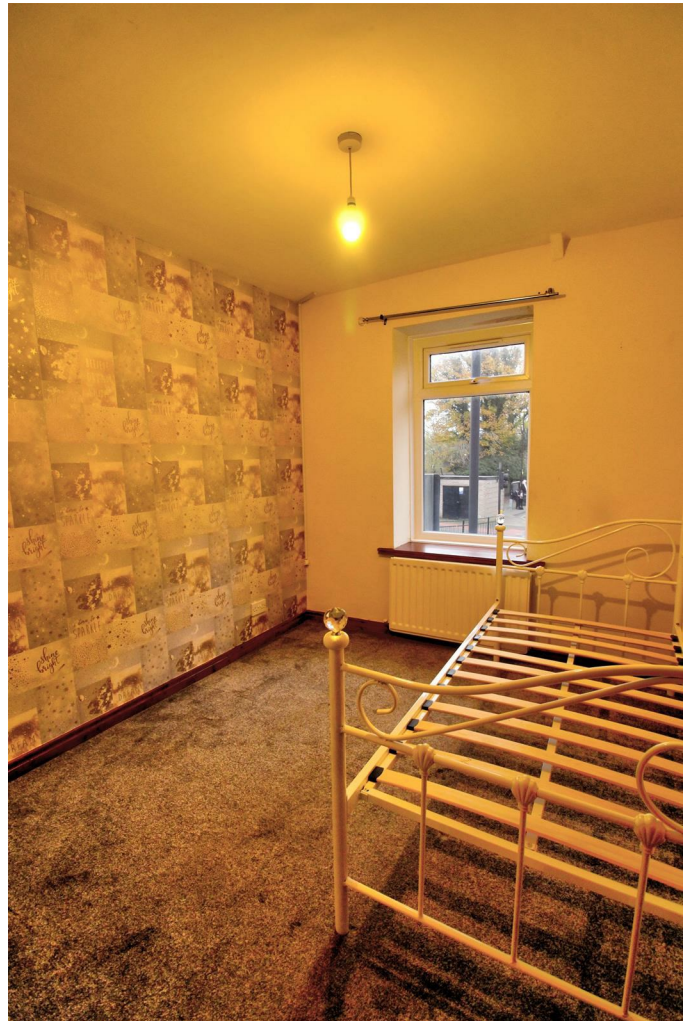

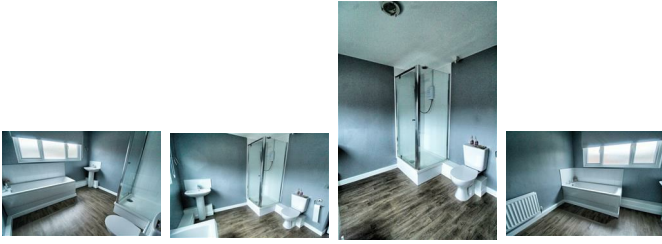

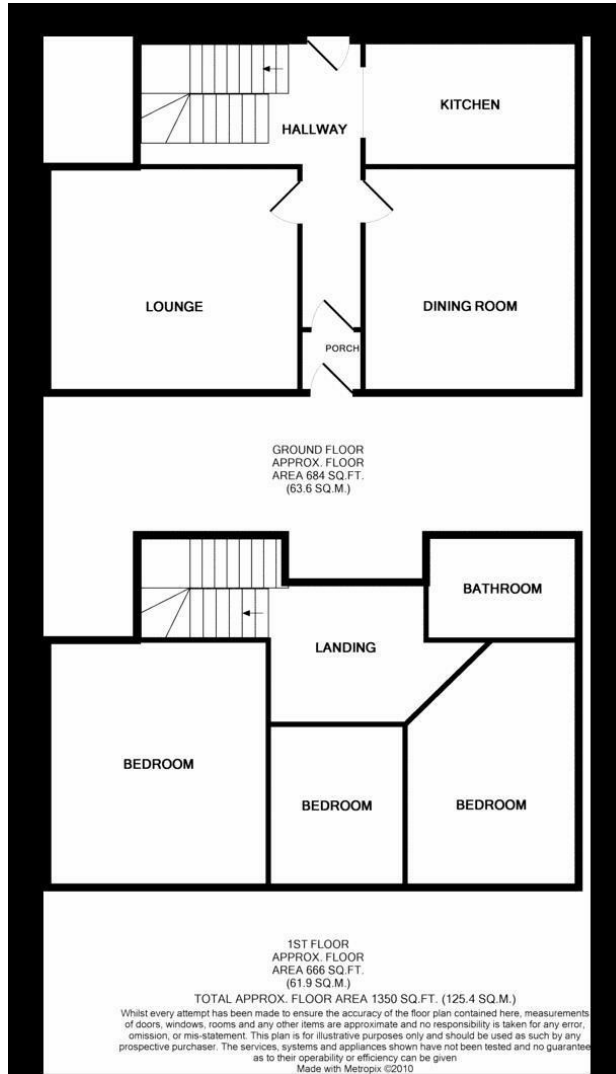

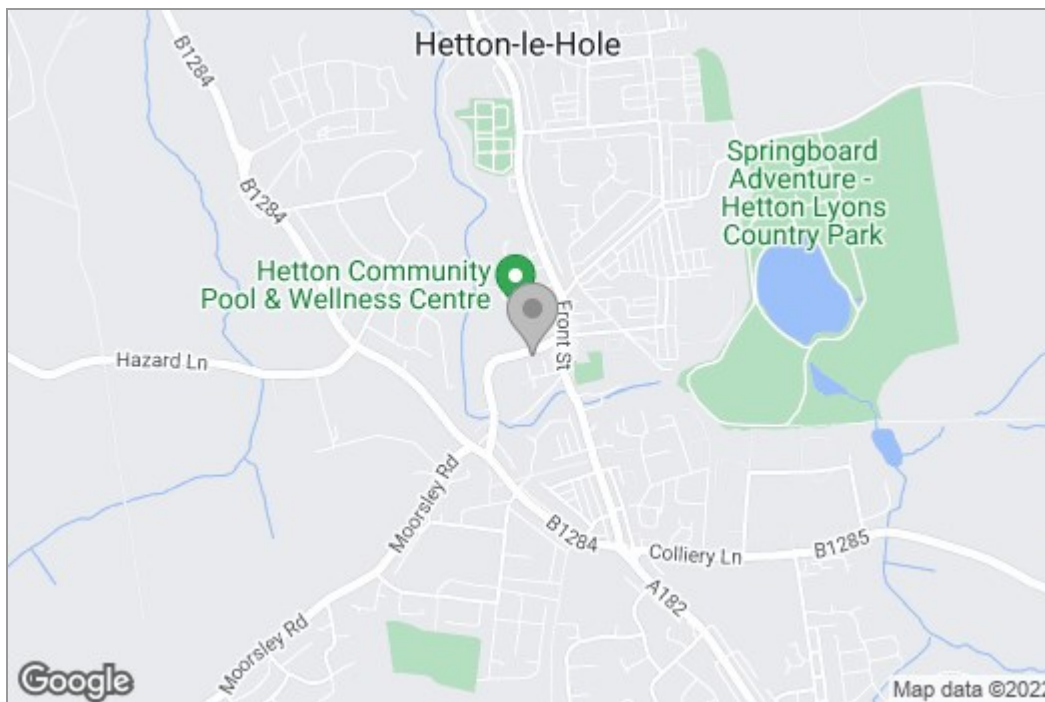

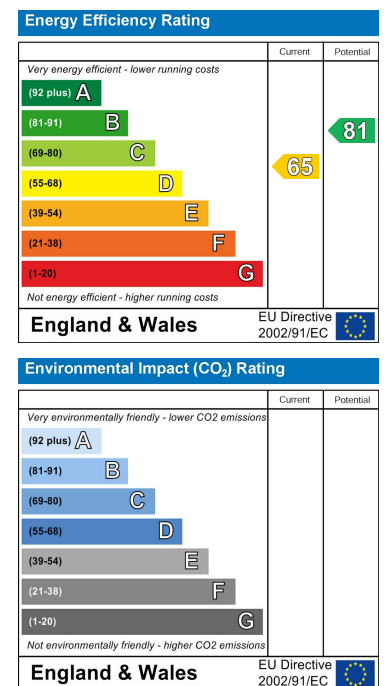
Floor Plan
