



## 21 Keeling Street, Newcastle, ST5 0DL Offers in excess of £110,000

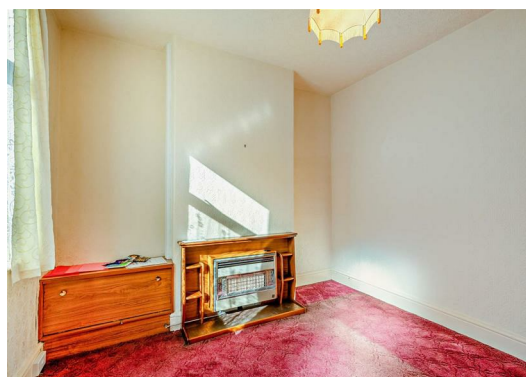

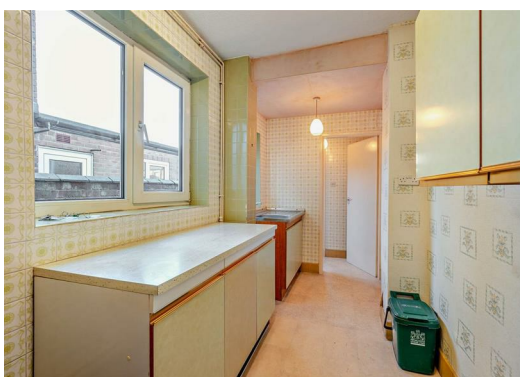
