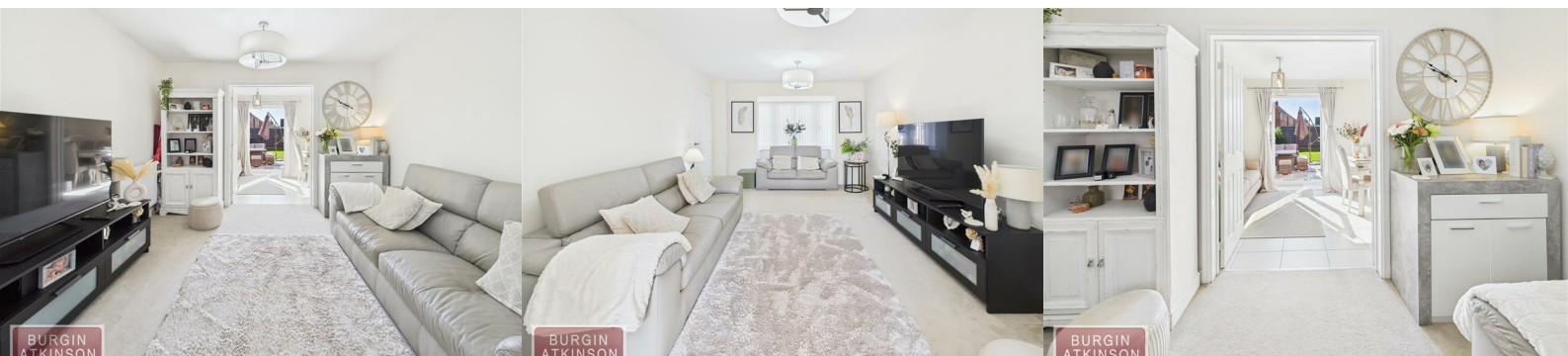

Description

This perfectly presented, four bedroom detached property is located on Gerard Grove, Retford. A particularly well located property with a 'good' rated primary school on the doorstep. Ideal for family occupation, this property is situated just on the outskirts of Retford Town. Retford boasts an abundance of amenities including shops, supermarkets, local retailers and a market three days a week. Retford Rail Station is positioned on the East Coast mainline and provides links to London in just one hour twenty five minutes as well as many other UK cities and towns. The A1 which provides easy access to the North and South of the country is just 10 minutes drive away.

Internally, this property begins in the welcoming entrance hall which provides access into the spacious yet cosy living room which features a bay window and double doors opening into the kitchen diner. The kitchen is modern with tiled flooring and fitted with fully integrated appliances. The living dining area offers double patio doors that open out onto the patio area. There is a separate utility room with a side door leading onto the tarmac driveway as well as a ground floor w/c with hand wash basin. Additionally, there is a second reception room to the ground floor which is currently utilised as a play room. To the first floor, you will find the master bedroom with freestanding wardrobes and a spacious en-suite shower room, a second double bedroom with free standing wardrobes and a further two double bedrooms. The main three piece suite bathrooms contains a bath with overhead shower, hand wash basin and w/c.

Externally, the landscaped rear garden is mostly laid to lawn with a patio area and a second patio area to the rear of the plot. To the side of the property is a tarmac driveway with parking access for two vehicles and a large detached garage.

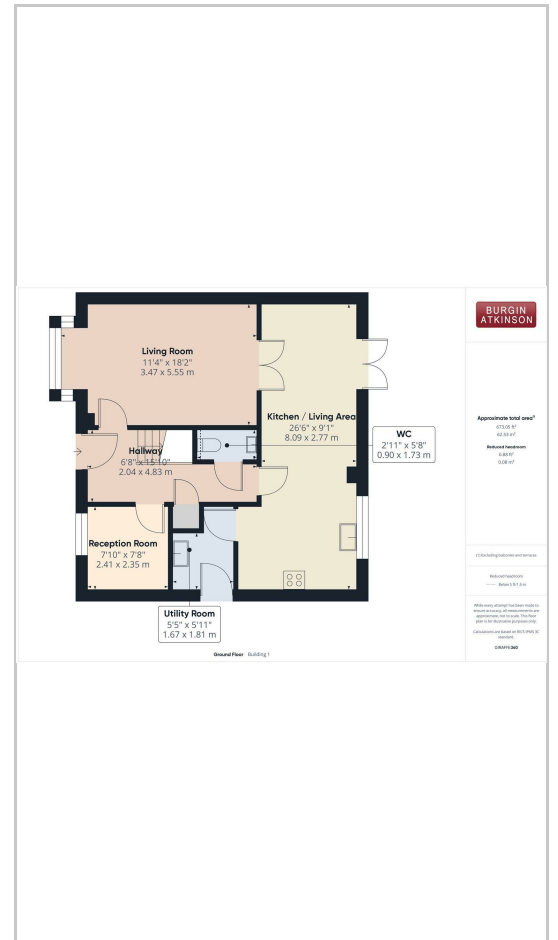

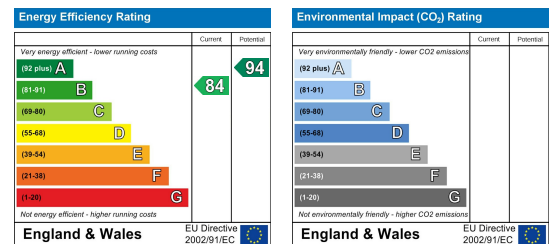
Area Map
