The property boasts a spacious lounge diner, kitchen/breakfast room, two double bedrooms, a well-presented three-piece shower room, and a generous conservatory. On entering the property, you are initially met by a wide entrance hall, containing a number of storage cupboards and access into the loft. Central to the property is the kitchen/breakfast room that offers access into the 6.5 metre long conservatory, containing plumbing for a washing machine. To the right hand side of the property, two double bedrooms are found alongside a well-presented shower room.

Outside the front of the property, a driveway is situated, leading to a useful single garage. The garage has only recently had a new roof in 2018. The impressive wrap-around garage is a tremendous size, benefiting greatly from its stunning open field views to the rear. 


