The gas centrally heated layout includes a lounge diner with beamed ceilings, kitchen with a door leading to an enclosed courtyard, first floor landing, one double bedroom and a bathroom. Affording space for both comfortable sitting and dining, the reception room features beamed ceilings. With carpet flooring, central heating radiator, built in meter cupboard and a door leading to the:

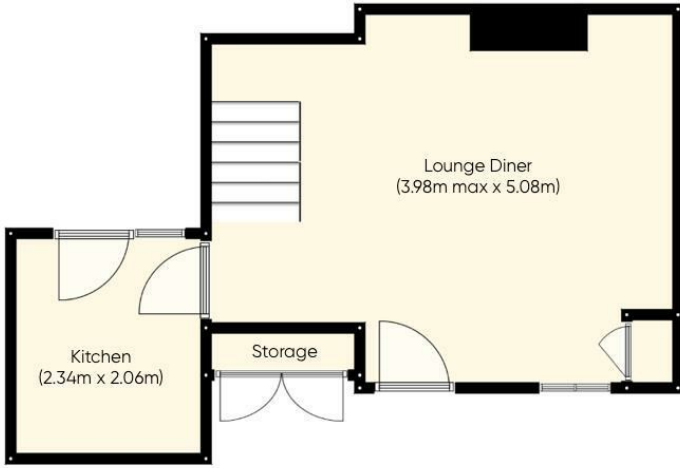
