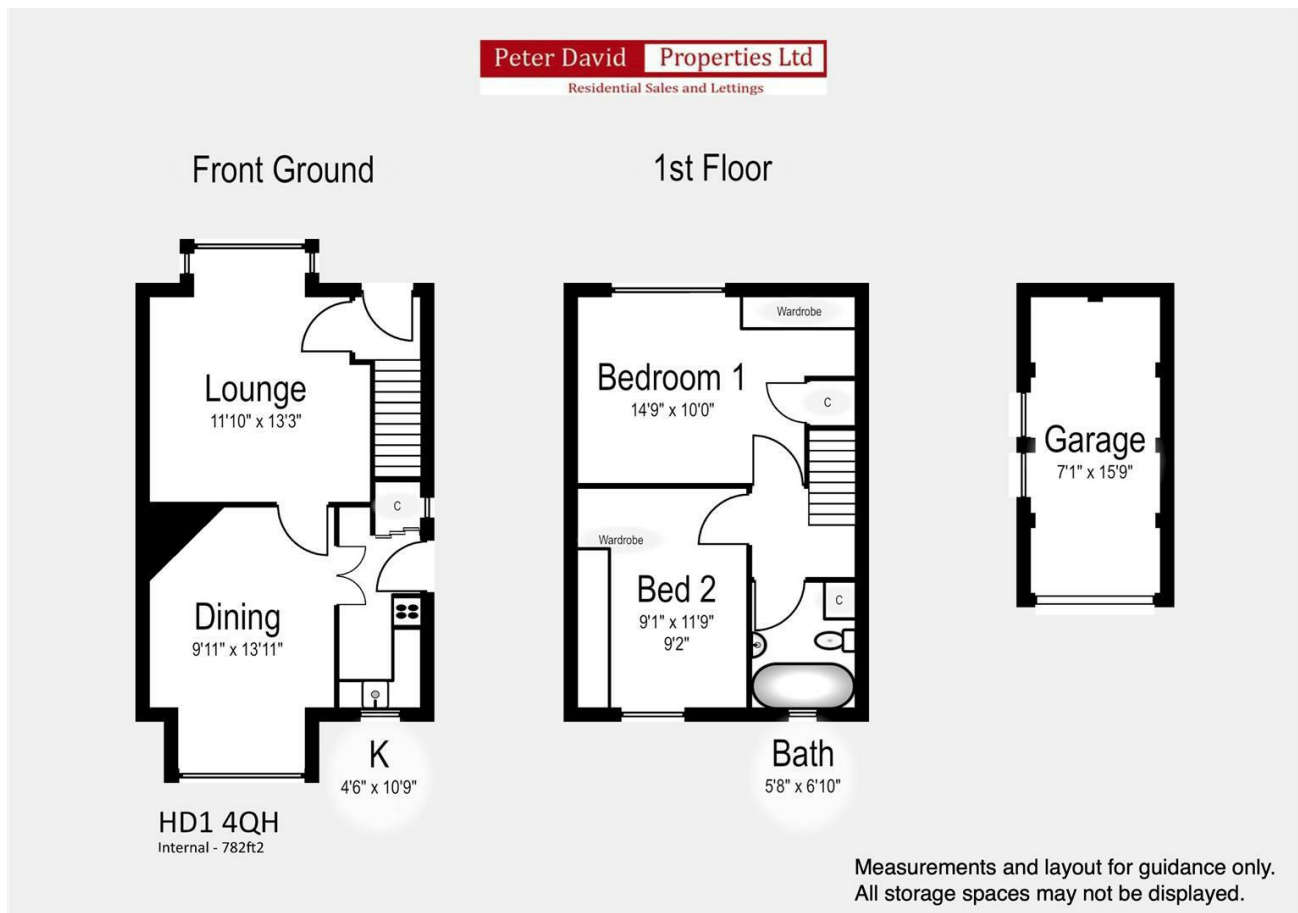
## Hybrid Map
