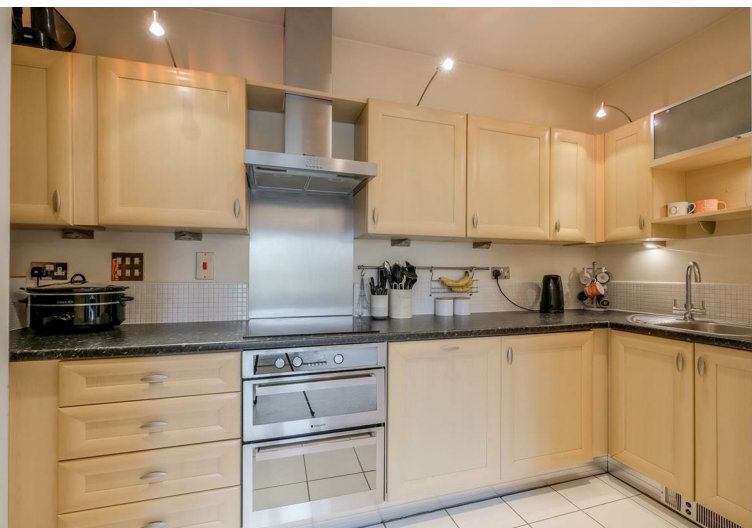

the apartments with a playground. An under cover allocated parking space and additional visitor spaces.

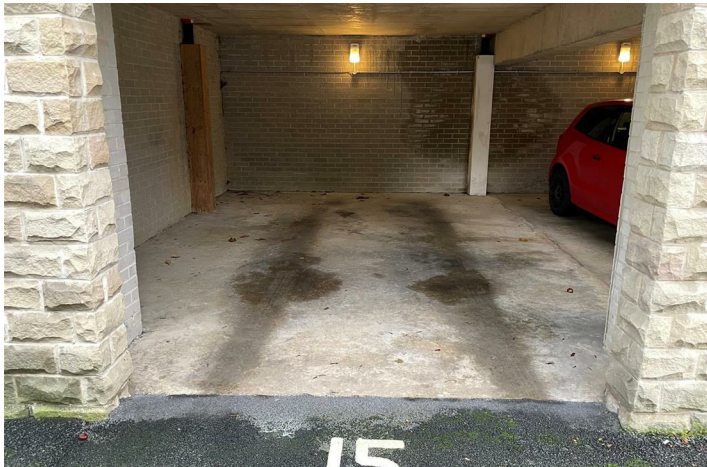

## Road Map



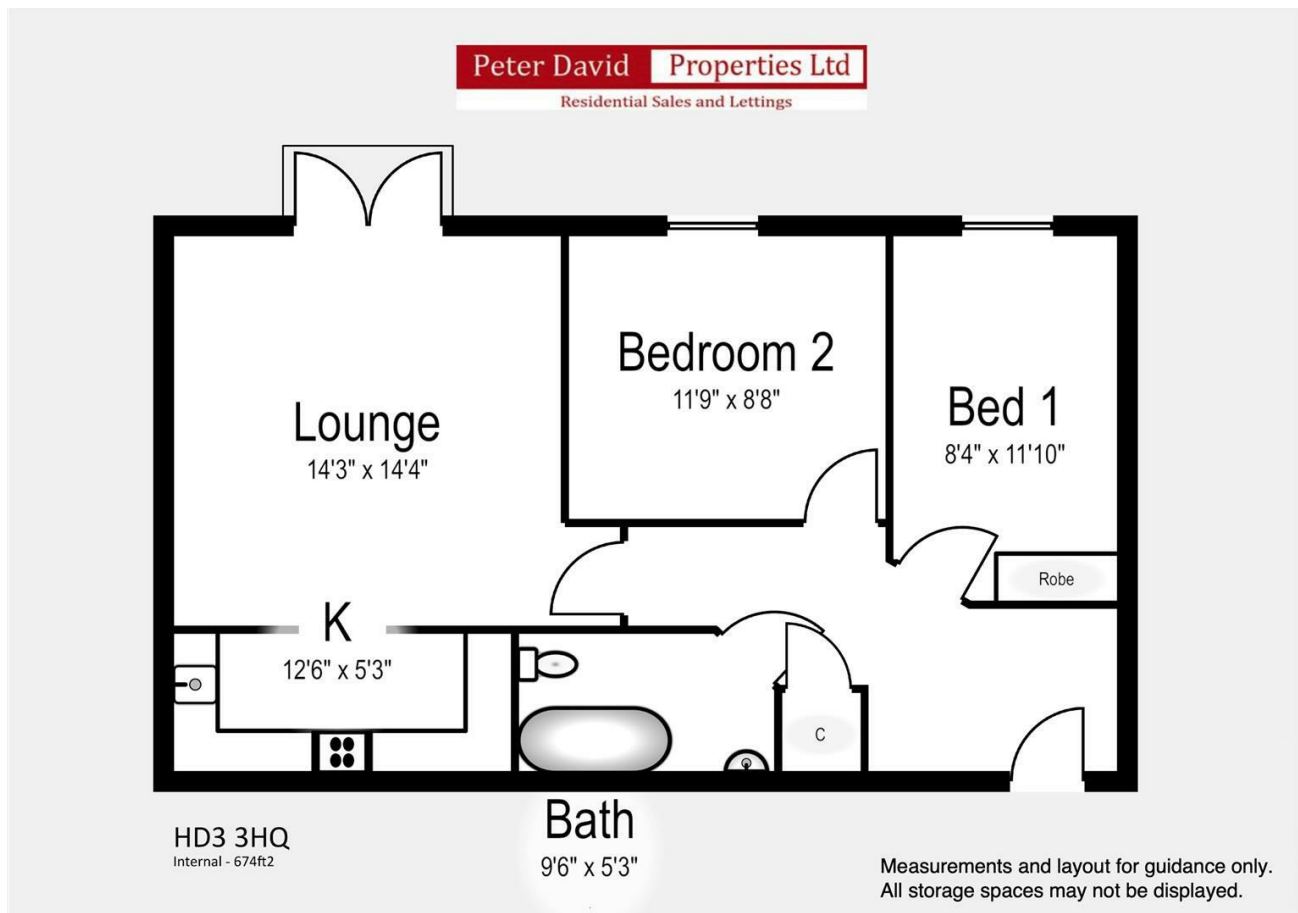
## Hybrid Map



## Terrain Map



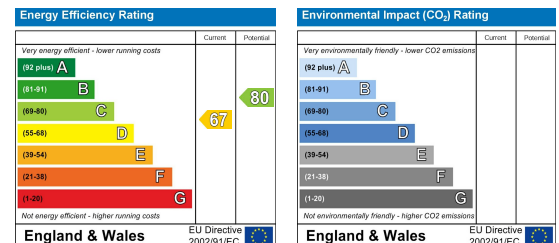
## Floor Plan
