## Entrance Vestibule

Enter the property through a PVCu door with coir matting. Access into the living room.

## Living Room

A spacious living room with a neutral carpet. PVCu window to front aspect.

## Downstairs W/C

A useful ground floor WC with tiled flooring. Comprising of: WC, a wash basin and tiled splashback.

## Kitchen / Diner

This kitchen diner is to the rear of the property and has tiled flooring, matching wall and base units and laminate worksurfaces. Integrated appliances comprise of: an electric oven, a gas hob, an extractor, a washing machine, a dishwasher, a fridge freezer and a stainless-steel sink and drainer under a PVCu window. PVCu patio doors lead out to the rear garden.

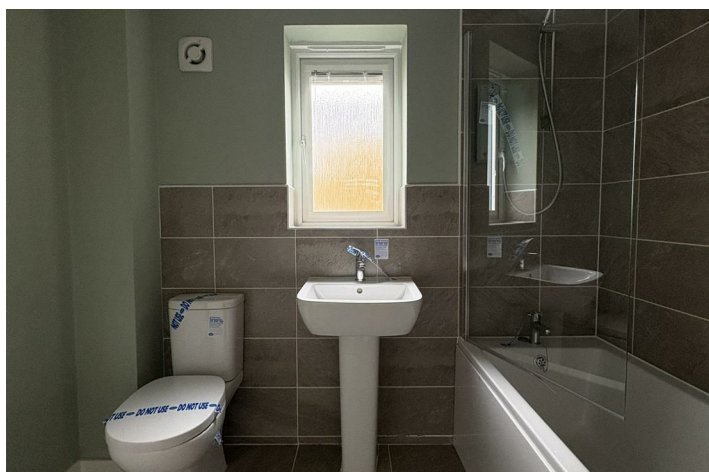

## Road Map



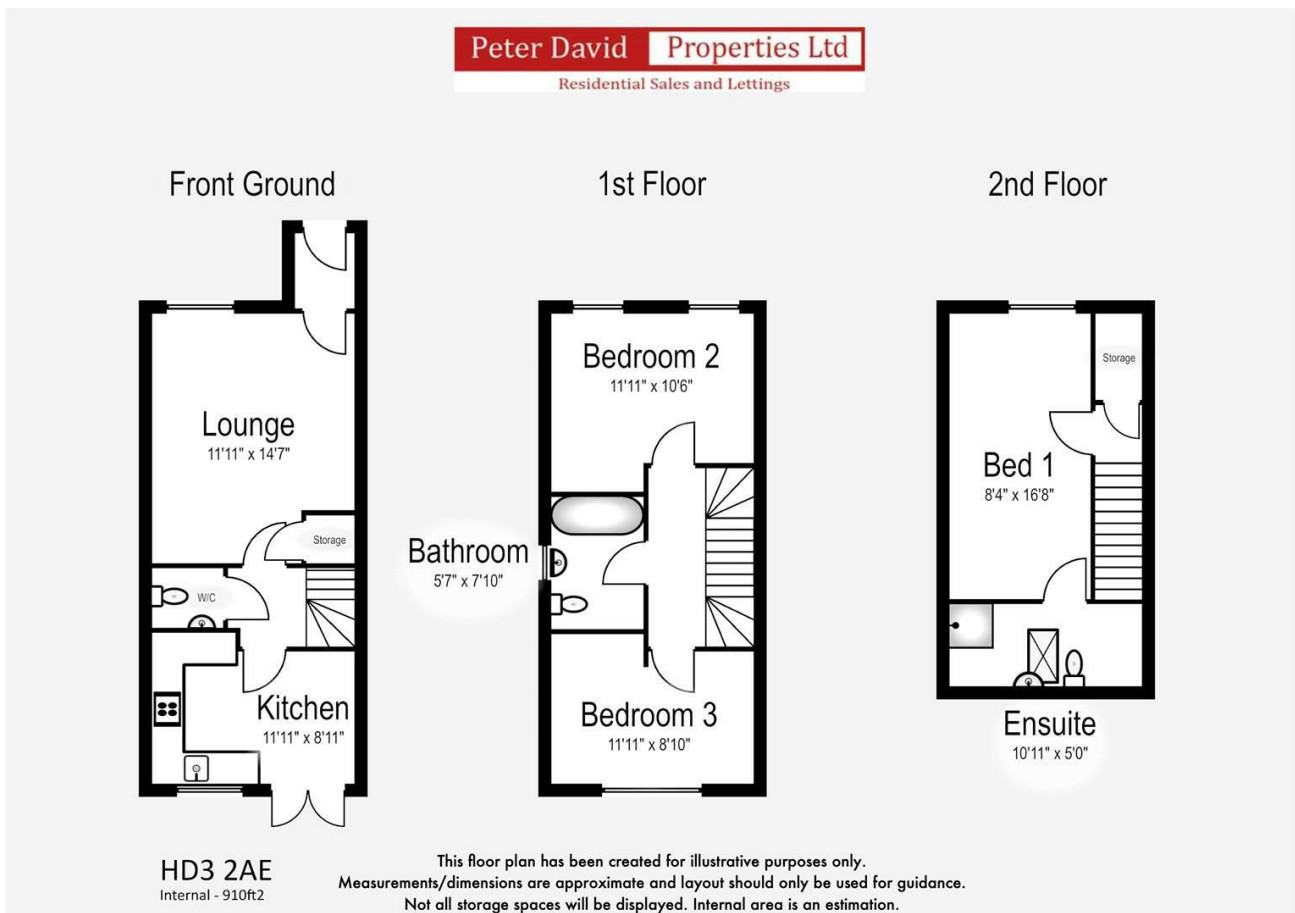
## Hybrid Map



## Terrain Map



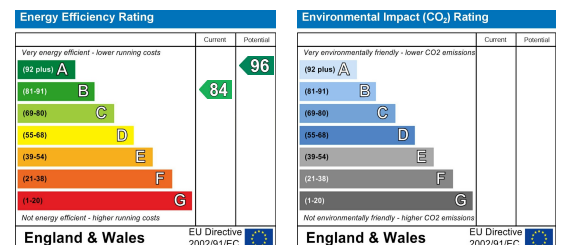
## Floor Plan
