Entrance Hallway

The property is accessed via solid wood door into the entrance hallway. Laminate flooring flows throughout the ground floor. Access to downstairs WC, kitchen and living room

Downstairs WC

A useful downstairs WC, with WC and hand basin. Tiled flooring and PVCu privacy window to the front aspect.

Kitchen

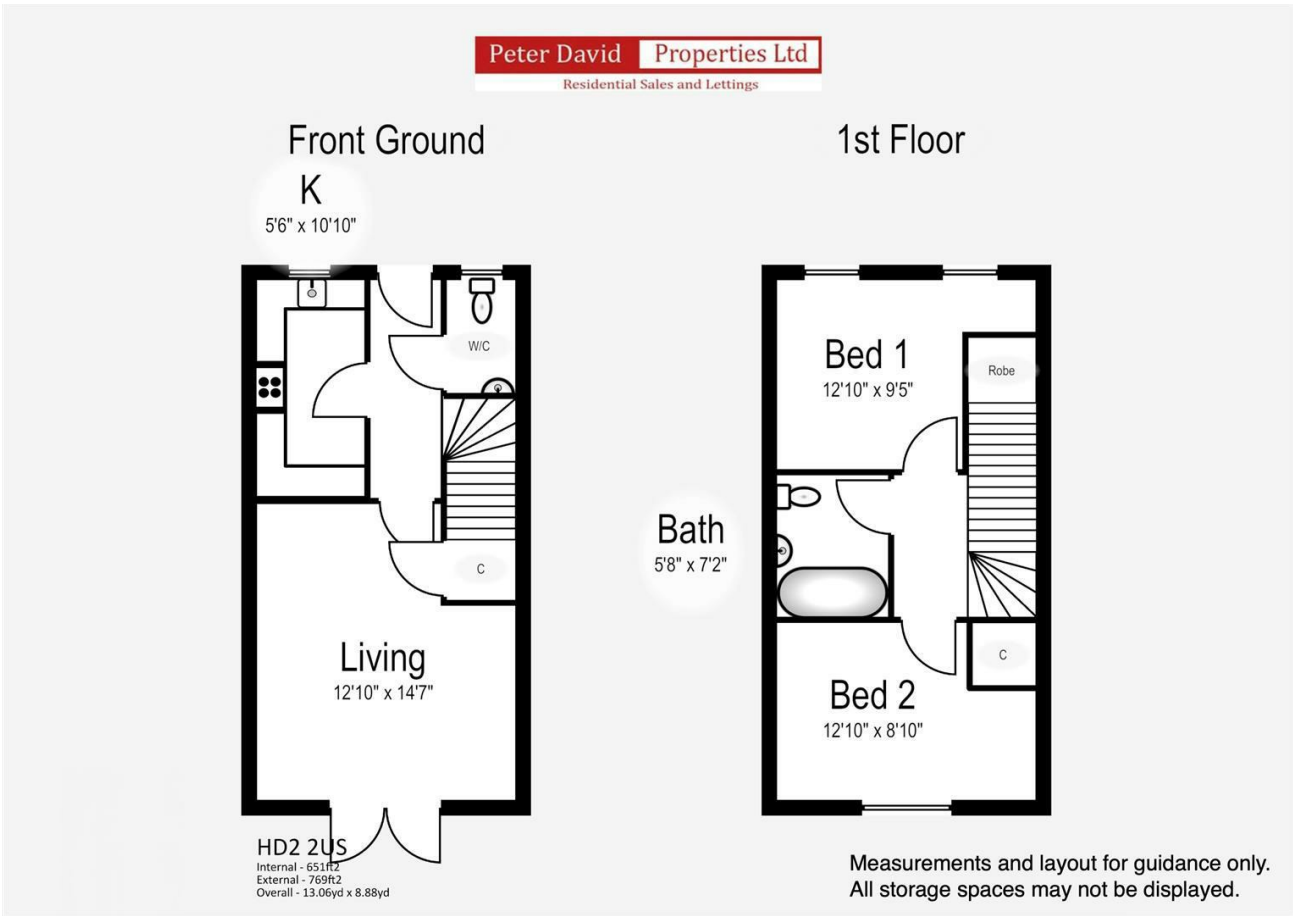
Hybrid Map



Terrain Map



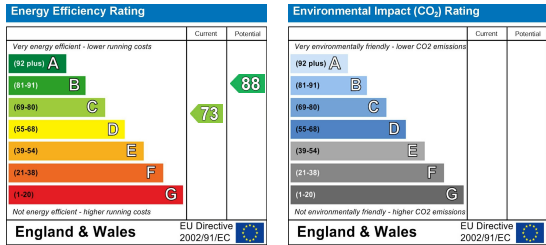
Floor Plan
