## Kitchen

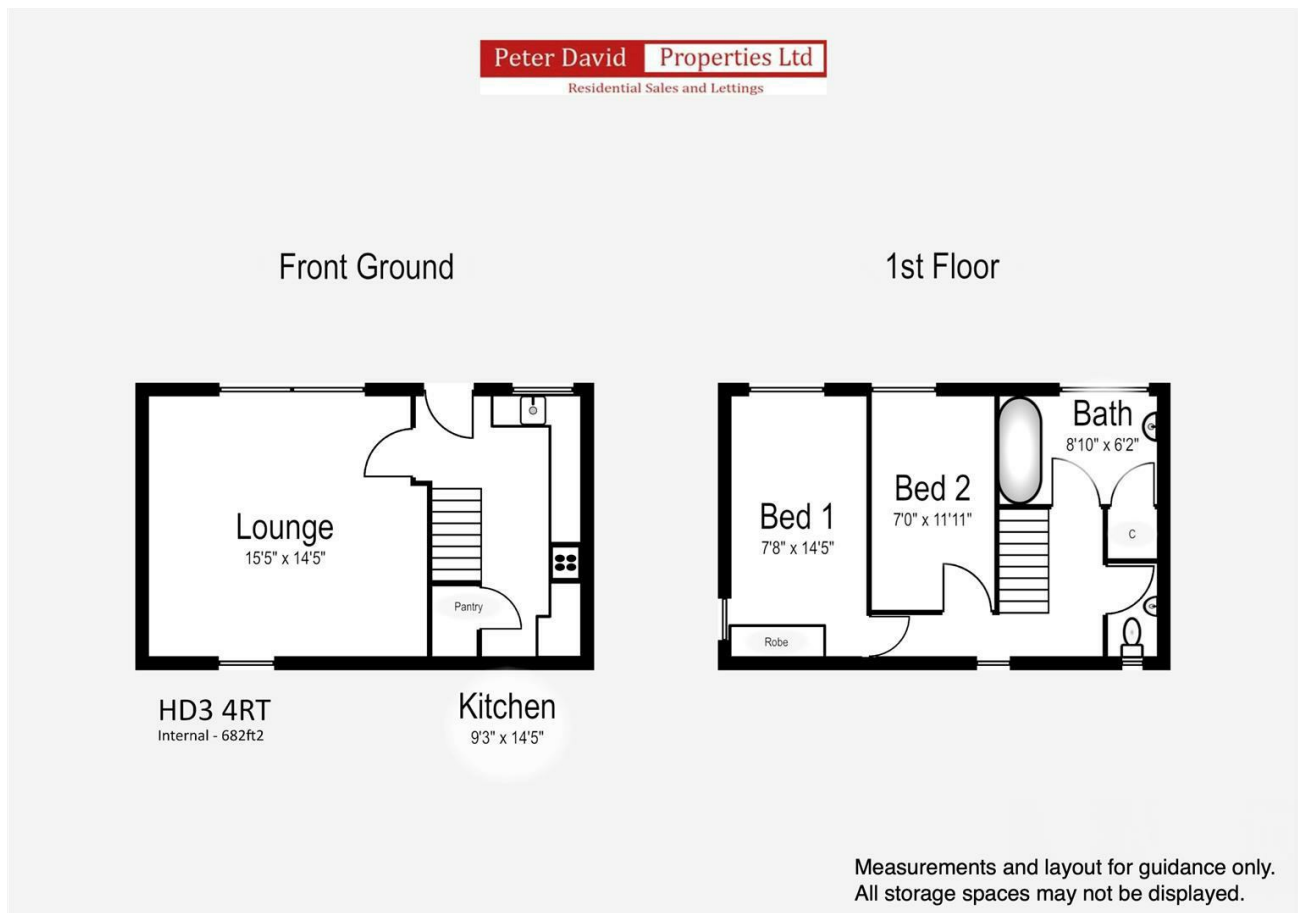
## Hybrid Map



## Terrain Map



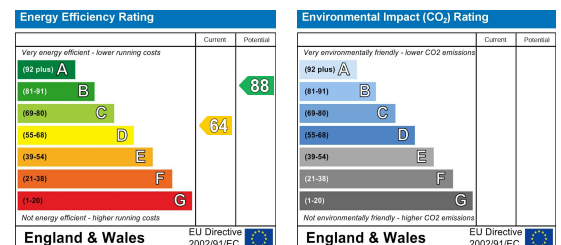
## Floor Plan
