Punnetts Town is a friendly village with a Primary & Pre-School, active village community hall, recreation field with children's play area and a medical centre, all right on the doorstep. The nearest shops are at Broad Oak and Rushlake Green, with many pubs in the surrounding area. Heathfield High Street shops and services are just 3 miles away, while Heathfield Community College is within walking distance, being under 1.5 miles.

This end-terrace Victorian cottage is well-presented and benefits from double glazing and a wood burning stove. The sitting room is at the front, with a wide window, oak flooring and fireplace with wood burning stove. The kitchen/dining room has a tile floor and is fitted with modern white coloured units having wood effect worktops with space for washing machine and cooker with hood over, stainless steel sink and drainer. There is ample room for a table and chairs. A door leads out to a conservatory, also with tiled floor.

On the first floor are two bedrooms. Bedroom 1 is at the front and enjoys far-reaching views over beautiful rolling countryside as far as the English Channel. There is an airing cupboard with hot water tank. The second bedroom has a window to the rear. The bathroom is fitted with a modern white suite with bath and separate shower cubicle, wash basin and WC, wall and heating floor tiling.

At the front of the house is a double width parking area, with gated side access to the back garden, which is fence enclosed and laid to lawn with an old well head and large garden shed.
