This detached period property is of brick construction beneath a blue slated roof. As the name suggests it was formerly a Gatehouse and it has until recently been let. However, it is now subject to a Prohibition Order Ref 24/01772/HCPT as requiring modernisation and improvement.

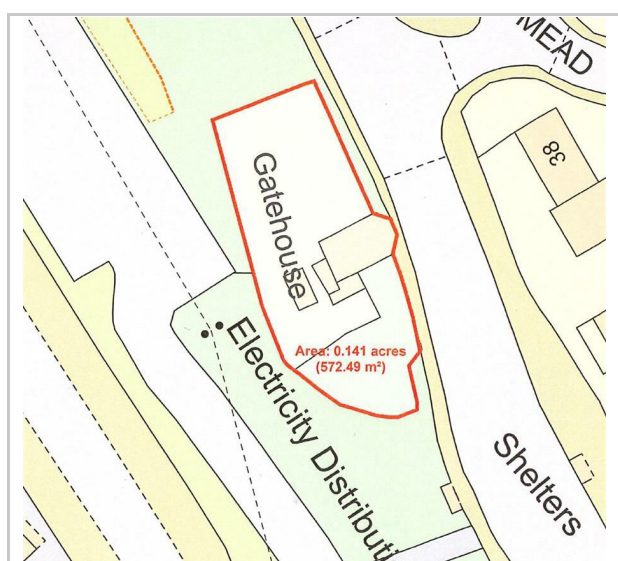
