## BOURTON-ON-THE-WATER

Is one of the larger of the North Cotswold Villages, renowned for its beauty, with the shallow River Windrush flowing through the centre, spanned by low arched bridges and flanked by wide Village Greens. It has many family attractions including Birdland, a Model Village, Motor Museum, and Perfumery, and has the benefit of excellent shopping facilities, various places of Worship, varied social and sporting activities, good educational facilities and regular 'bus services. It is some 4 miles from Stow-on-the-Wold, 8 miles from Kingham Station (Paddington about 80 minutes), 16 miles from both Cheltenham and Cirencester and 28 miles from Oxford.

## DESCRIPTION

2 APRIL RISE is a ground floor, one bedroom apartment, located centrally within the village. The property, which has the benefit of double glazing throughout is as follows (all measurements being approximate):

## DIRECTIONS

From the Tayler and Fletcher office in Bourton-on-the-Water, proceed left along the high street to the junction with Station Road. Turn left onto Station Road and on reaching the petrol station turn left into the car park just beyond. The property can be found to the back of the car park on the right hand side.

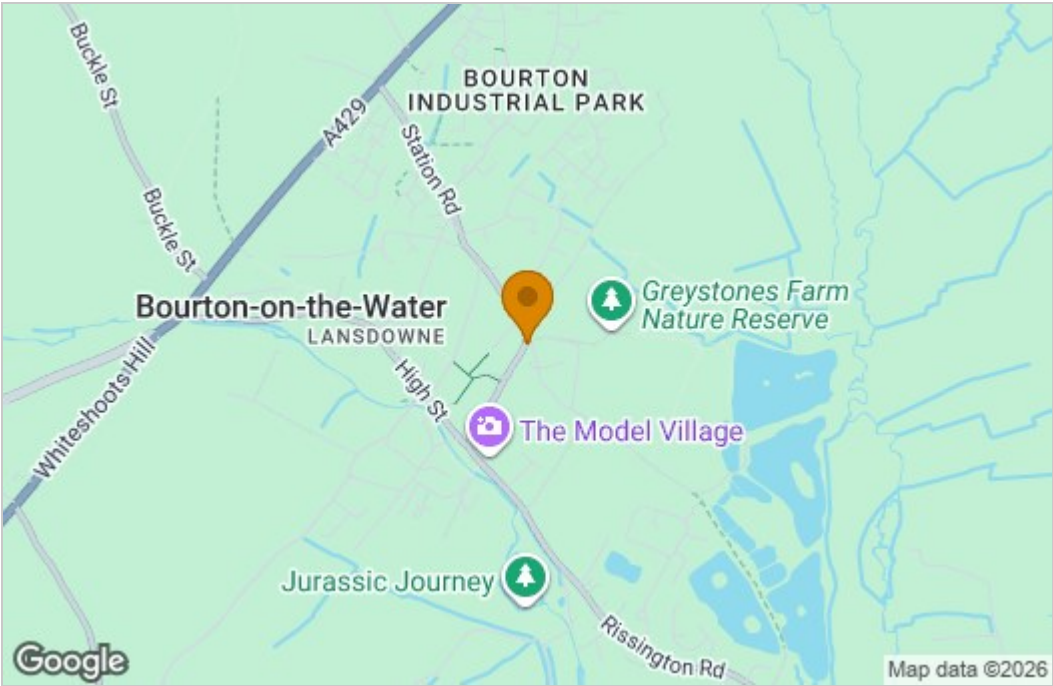

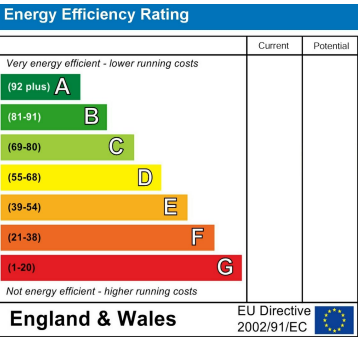
