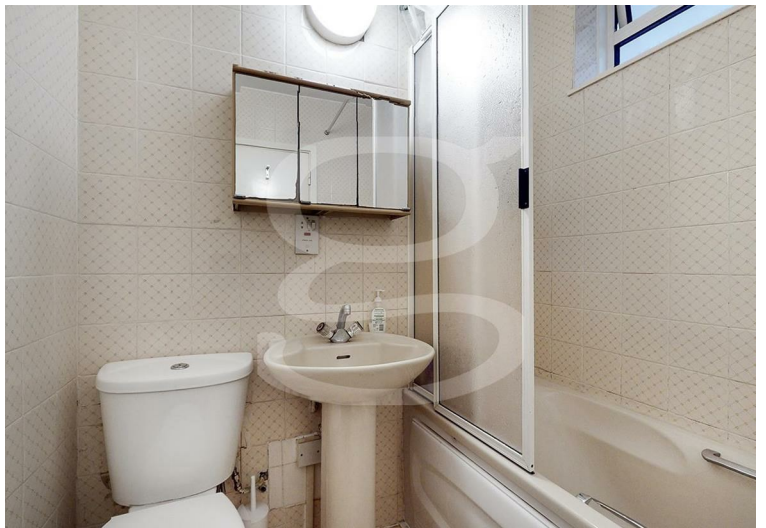
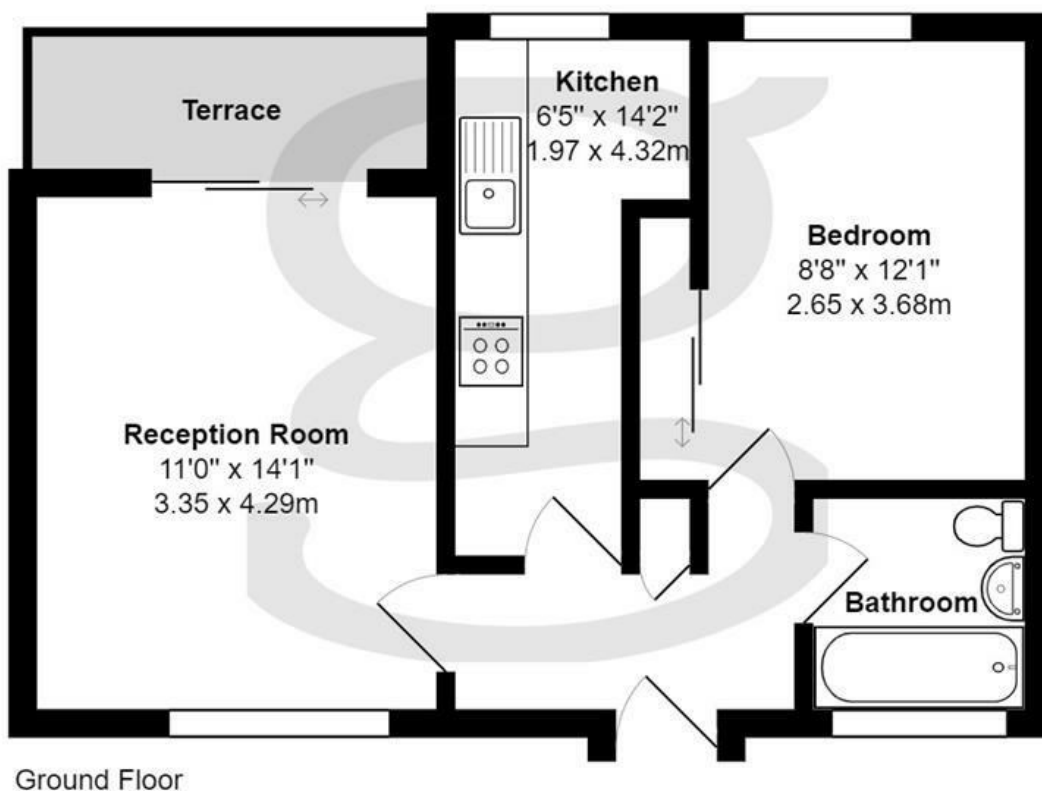




Boundary Road, St Johns Wood, NW8 £425,000 Subject to contract

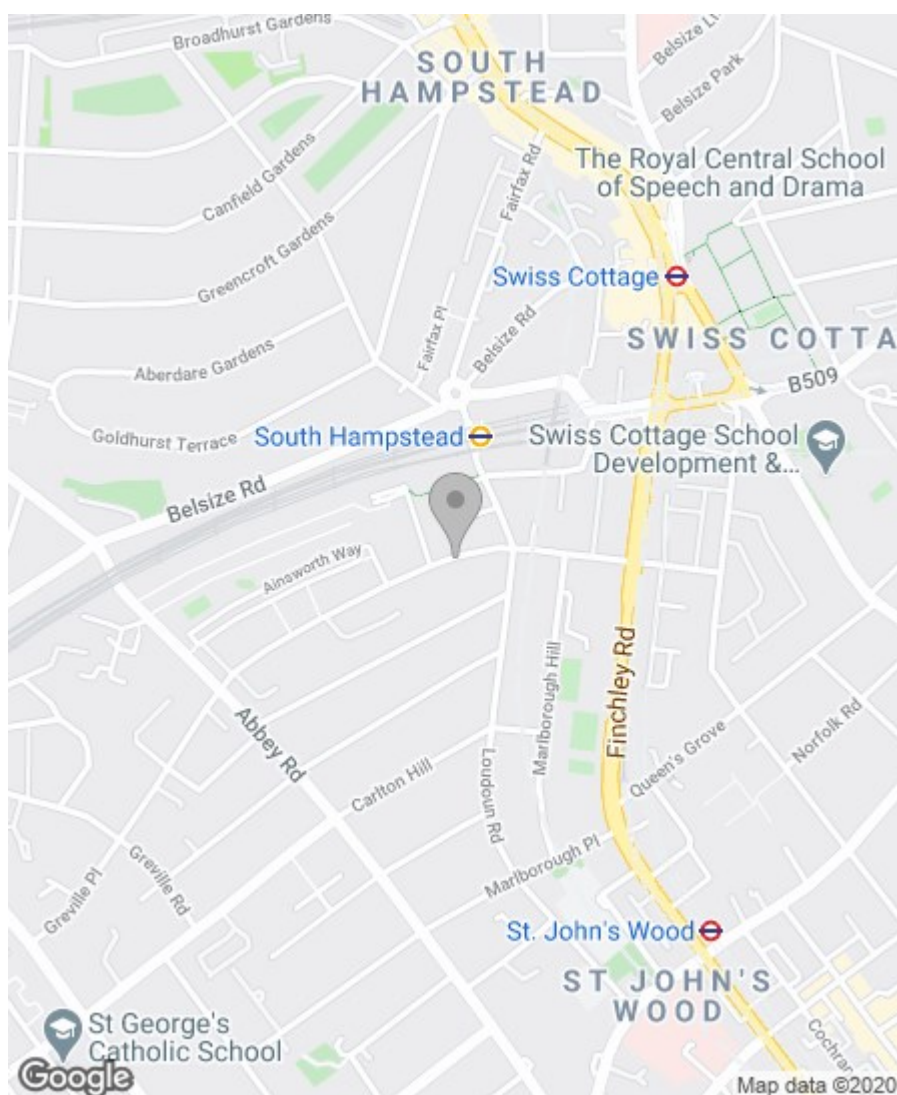
