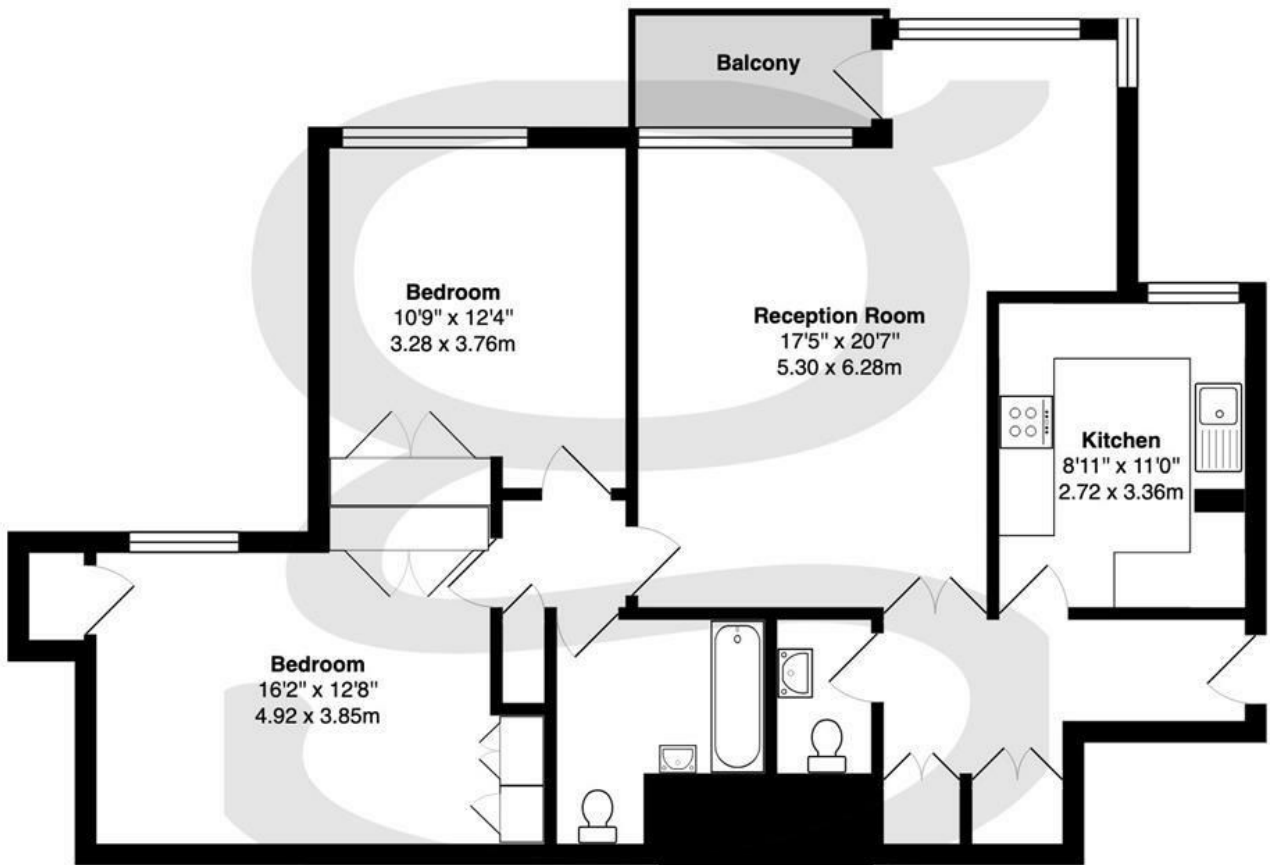




## Marlborough, Maida Vale W9 £500,000 Subject to contract
