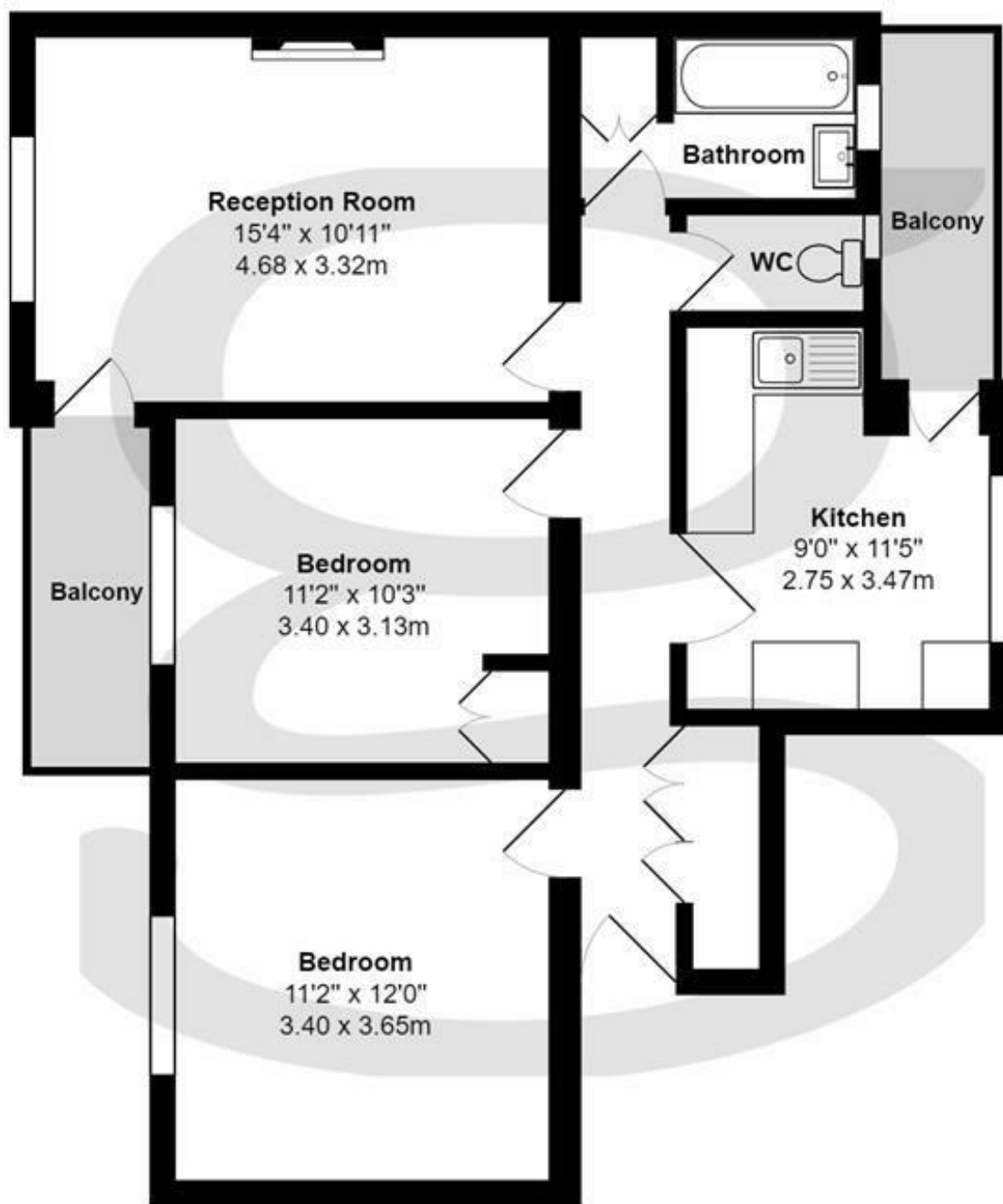




## Boundary Road, St Johns Wood, NW8 £450,000 Subject to contract
