No Building management fee, but any fees needed split on a pro_rata basis between the two flats and the shop. Wight fire alarm costs approx £60 PA.

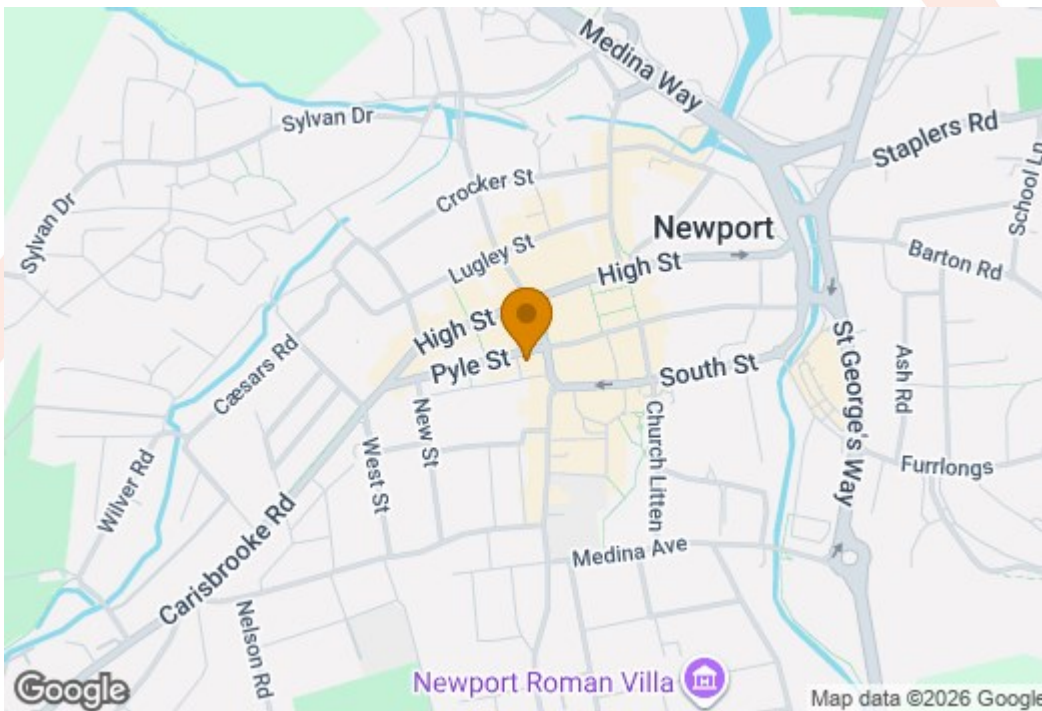
PARKING: Residents are eligible for a parking permit in the St. Chapel car park.
