Concrete area adjacent to the house, two brick outdoor stores, timber garden store, green house, lawn, mature planting.

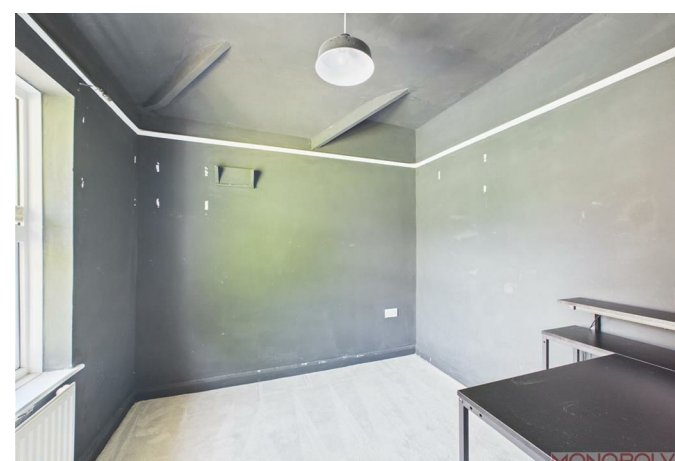

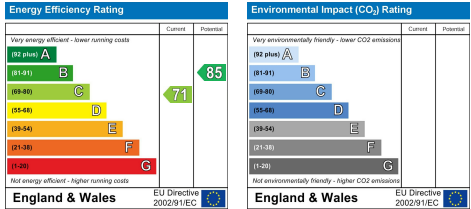
