FREEHOLD - This charming 4 bedroom 4 bathroom barn conversion has been completely renovated throughout and now offers the new owner a fabulous four bedroom home.

The property is located in Trinity yet only 10 minutes away from the town centre. Located on an excellent bus route and also near a choice of lovely farm shops.

Accommodation is set over three floors. On the ground floor is an entrance hall with good storage, a cloakroom, utility room, and a kitchen and dining room with pocket doors leading to a great sized living room. Both rooms have access to the garden.

On the first floor is the owners suite with beautiful rural views, a dressing area and an en-suite bathroom. There is a second double bedroom with en-suite, a single bedroom and a house bathroom. On the second floor is a large bedroom suite.

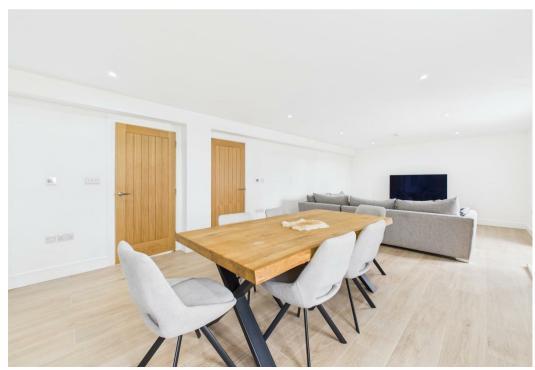
Outside, the south facing garden overlooks the surrounding countryside and is split level; the lower area with a natural stone terrace, and the remaining area is laid to grass.

The houses are set around a paved communal courtyard, there is a separate designated parking area and this house has private parking for 2 cars plus another by the front door

Also included is a communal bike store, communal bin store and each house takes ownership of a pigsty for storage use.



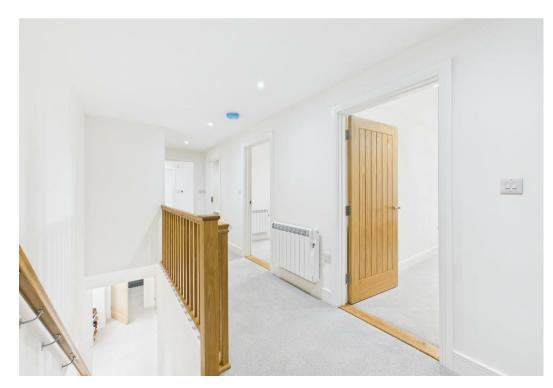
