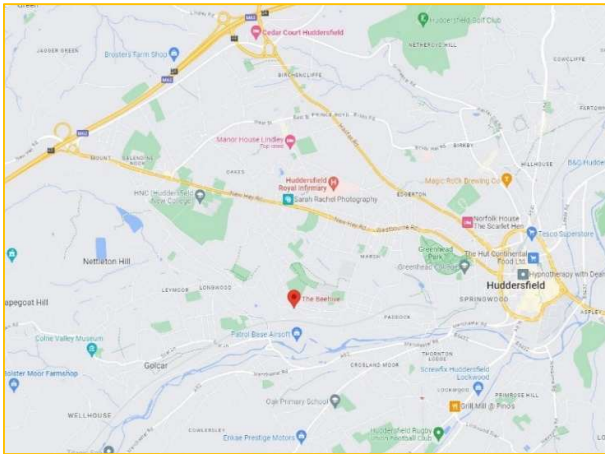
The property occupies this two storey office building which has been divided into multiple offices let at fully inclusive rents.
