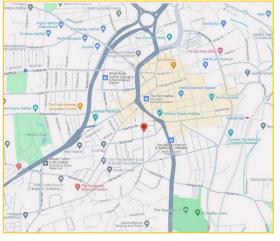
The property comprises a character office building constructed of stone with ashlar stone facing, providing accommodation over 4 levels.
