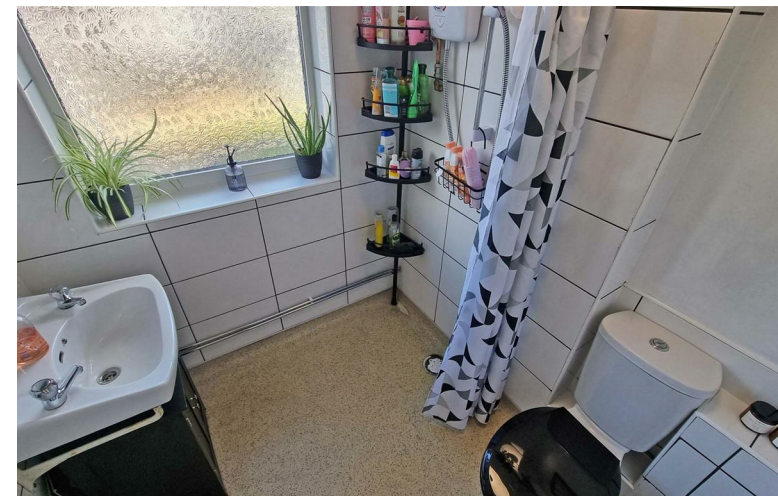
Situated in this most convenient location set back from the main Alcester Road South behind a hedged parking area.

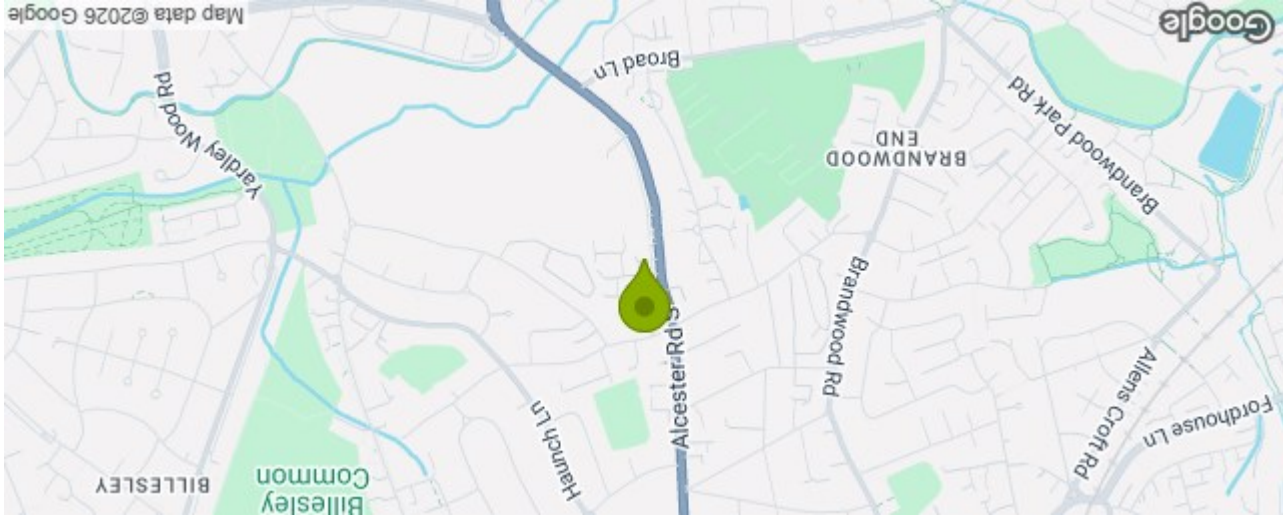

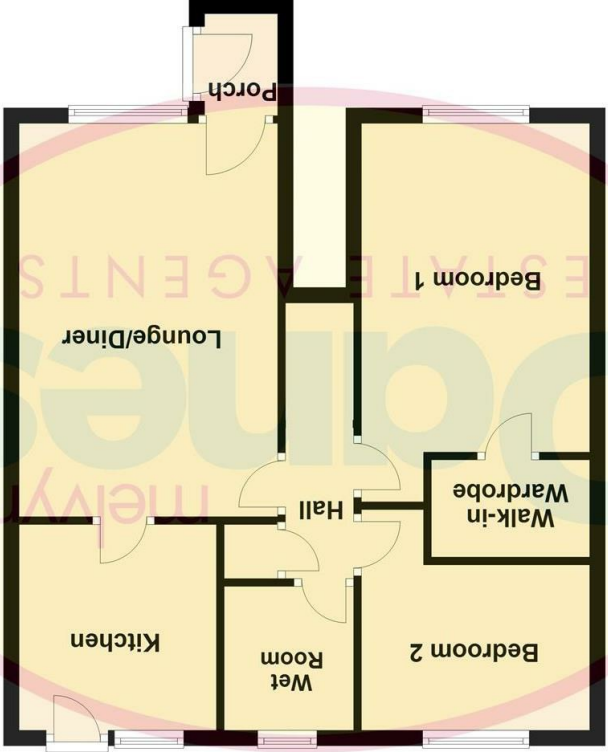
