## Description

A well presented semi detached house in this popular cul de sac location ideally situated for the local amenities in Wythall and Hollywood

There is local primary schooling at nearby Meadow Green, Coppice Primary school and Woodrush Senior School on Shawhurst Lane in Hollywood. Education facilities are subject to confirmation from the Education Department.

Local shops can be found on nearby Station Road, Wythall and Drakes Cross Parade in Hollywood with Becketts Farm Shop close by. The property is just a few minutes drive or by bus to Shirley along Truemans Heath Lane and one can continue back through Hollywood to Sainsbury's at the Maypole island, which also provides access to Birmingham city centre and the southern Birmingham suburbs, along with the Hollywood by-pass which links to the M42, forming the hub of the national midlands motorway network.

There are railway stations close by in Wythall and nearby at Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham, Redditch and the surrounding suburbs.

Set back from the road via a block edged tarmac driveway, UPVC double glazed door opens into the porch with sliding door into the hallway with stairs rising to the first floor accommodation and doors to the dining room, lounge and refitted kitchen with side passageway giving access to the front and rear garden.

On the first floor accommodation there are three good size bedrooms and a shower room.

The rear garden is paved for low maintenance with fencing to boundaries.




