Description

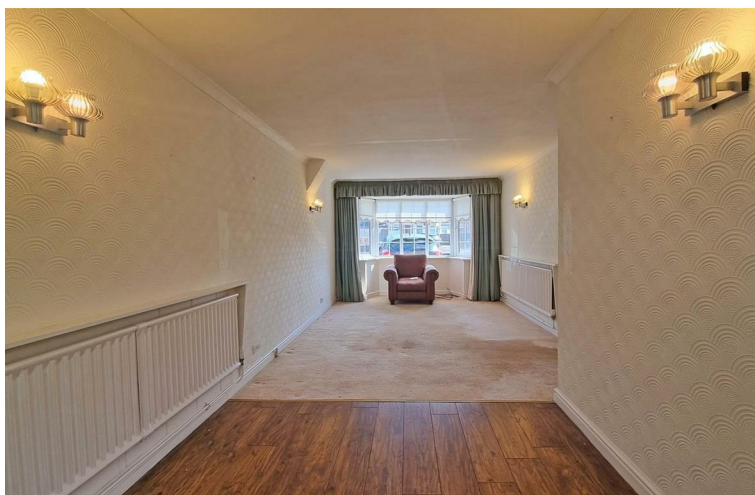
A well presented and extended traditional semi detached house with a superb mature rear garden close to the local facilities of Hollywood and Maypole with well regarded local primary schooling and Secondary School nearby, education facilities are subject to confirmation from the Education Department.

There is the benefit of local shops at Maypole including Sainsburys and easy access to the Alcester Road in Hollywood which in turn provides access to the M42 motorway forming the hub of the midlands motorway network.

There are railway stations nearby at Yardley Wood, Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham, Solihull, Kings Heath and the surrounding suburbs.

Set back from the road via a block paved driveway, a composite front door opens into the hallway with stairs to the first floor accommodation and doors to a large lounge diner with patio doors to the conservatory, modern kitchen and an extended utility with door to the rear garden and front driveway.

On the first floor there are doors to three bedrooms and a refitted shower room. The mature rear garden has a paved patio, lawn, flower, shrub and herbaceous borders, fencing to boundaries and gated vehicular access to the garage with electric roller shuttered door and parking.

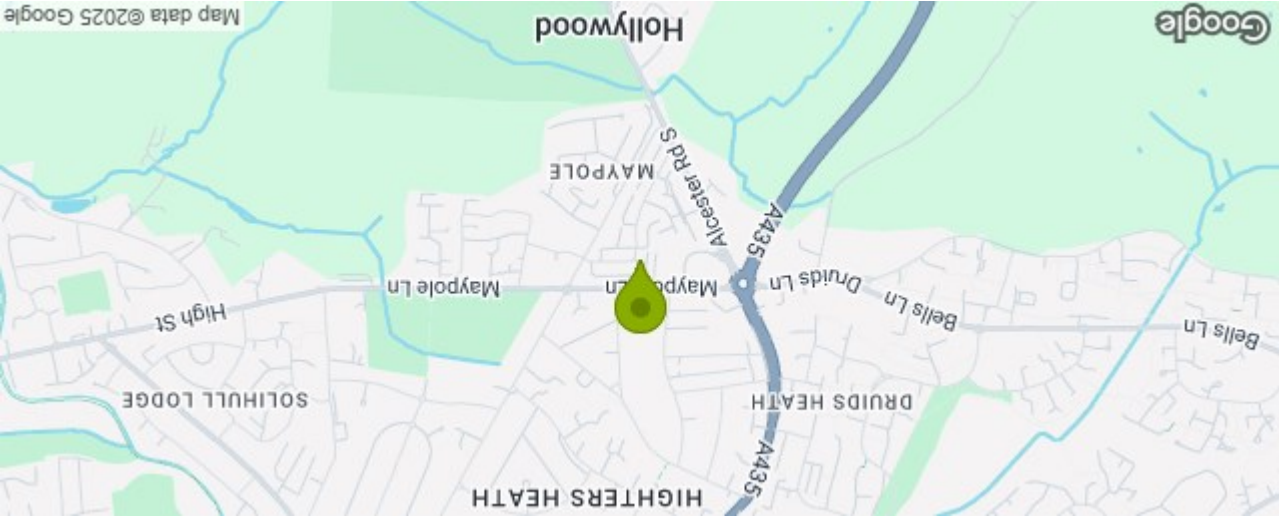

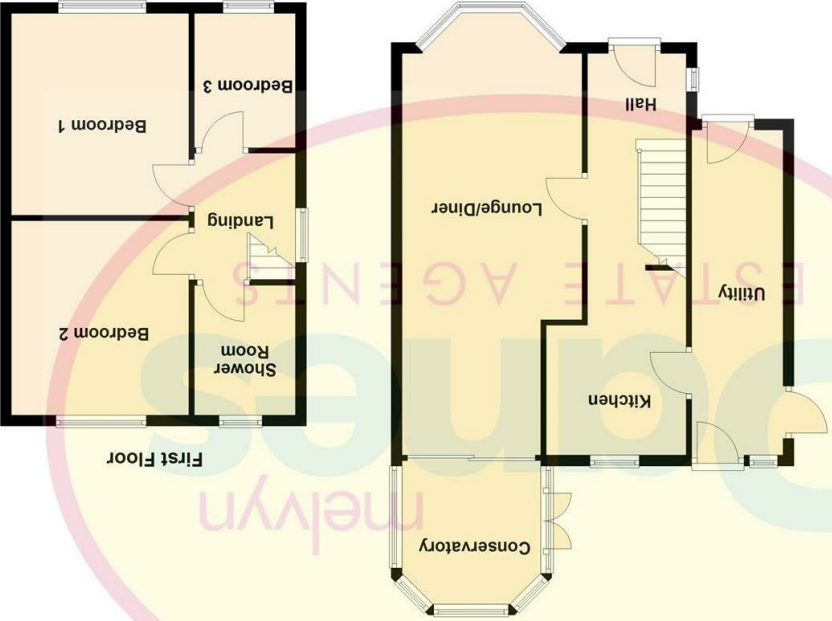

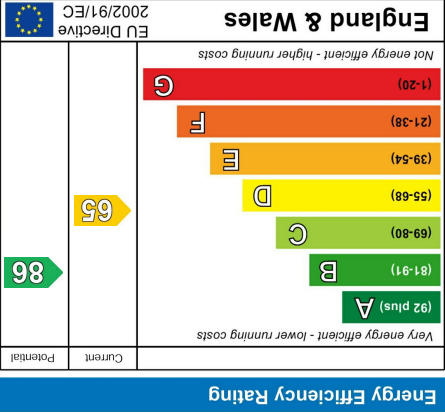
