Description

Situated in this popular and convenient location this end terraced house set on a double width plot with potential for extension or development subject to planning close to the local amenities of Kings Norton, Kings Heath and Maypole.

Close to well regarded local primary schooling and secondary schools, education facilities are subject to confirmation from the Education Department and there is the benefit of local shops at Maypole including Sainsburys and easy access to the Alcester Road in Hollywood which in turn provides access to the M42 motorway and beyond.

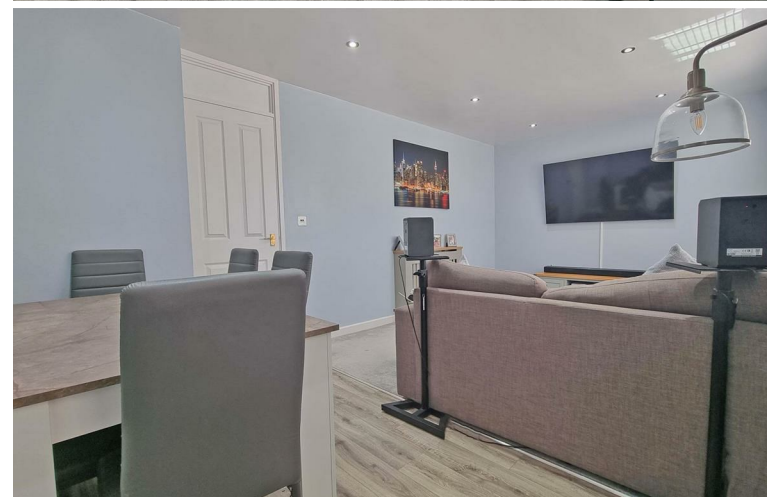
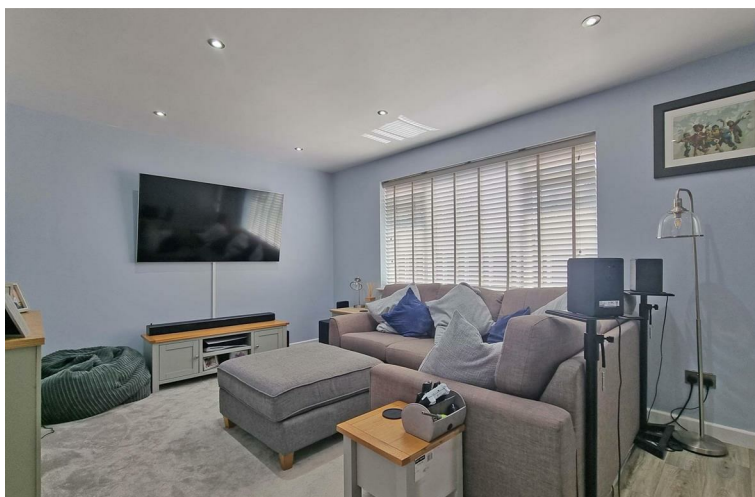
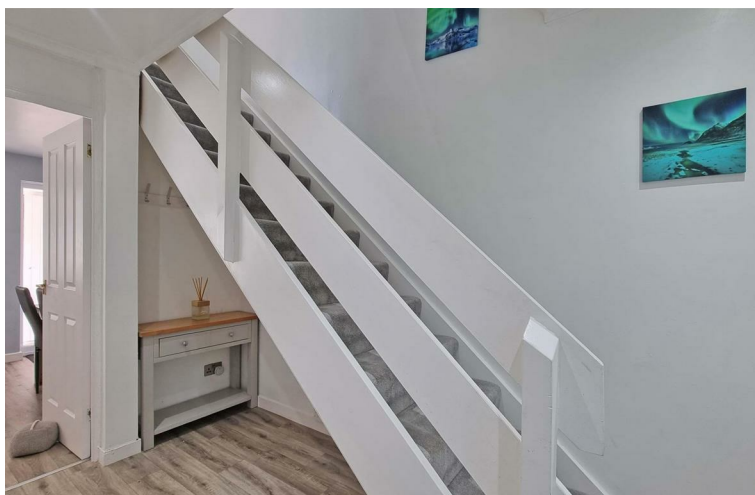
The property is situated within a short drive to Shirley along Maypole Lane and one can continue beyond Alcester Road to Birmingham city centre and the southern Birmingham suburbs, along with the Hollywood by-pass which links to the M42, forming the hub of the national motorway network.

There are railway stations nearby at Yardley Wood, Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham and the surrounding suburbs.

Set back from the road via a tarmacadam single driveway leading to a gated and landscaped front gravel garden with UPVC double glazed door opening into the porch with further UPVC double glazed door into the hallway with stairs to the first floor accommodation and doors to the guest cloaks WC, cloaks cupboards, modern kitchen diner and lounge diner with door to the rear porch opening into the rear garden.

On the first floor landing there are doors to two bedrooms, airing and storage cupboards and refitted bathroom.

The large double plot rear garden has a paved patio leading to extensive lawn with gated side access and fencing to boundaries.
