Description

This modern end town house offers well presented & well proportioned accommodation with potential for extension or development subject to planning close to the local facilities of Hollywood and Maypole with well regarded local primary schooling and Secondary School nearby, education facilities are subject to confirmation from the Education Department.

There is the benefit of local shops at Maypole including Sainsburys and easy access to the Alcester Road in Hollywood which in turn provides access to the M42 motorway forming the hub of the midlands motorway network.

There are railway stations nearby at Yardley Wood, Wythall and Whitlocks End offering commuter services between Birmingham and Stratford upon Avon, and local bus services provide access to the City of Birmingham, Solihull, Kings Heath and the surrounding suburbs.

An ideal location therefore for this most individual property sat back from the road via a large gated front garden with a footpath to the UPVC double glazed front door opening into the porch with bin store and door into the hallway with doors to the kitchen, guest cloaks WC, store cupboard and lounge diner with sliding patio style doors to the conservatory.

On the first floor there are doors to the three generous bedrooms and modern shower room.

The large side and rear garden are laid to lawn with fencing to boundaries and gated access to the front and rear leading to the rear garage and double driveway.

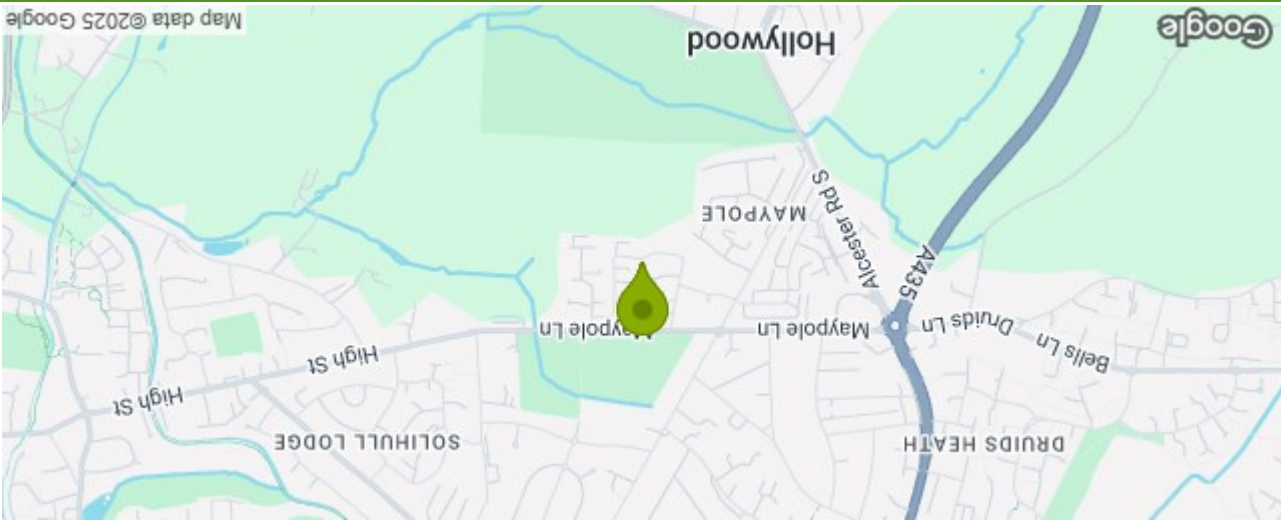
