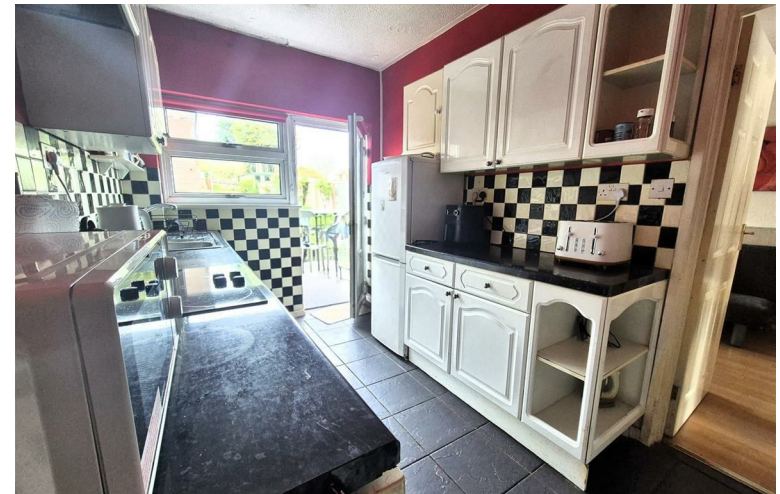
Description

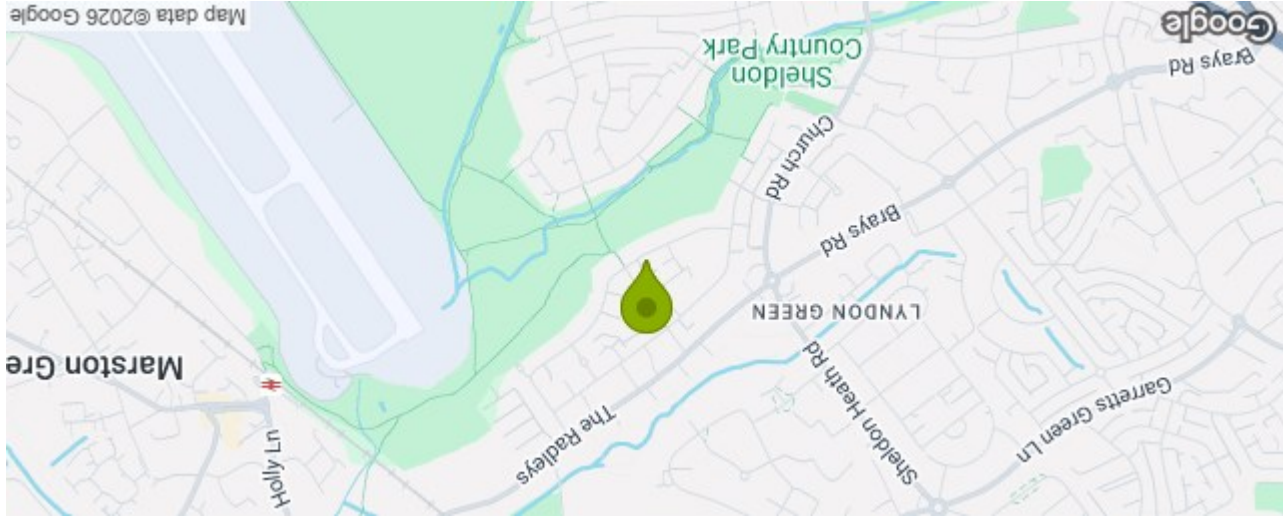

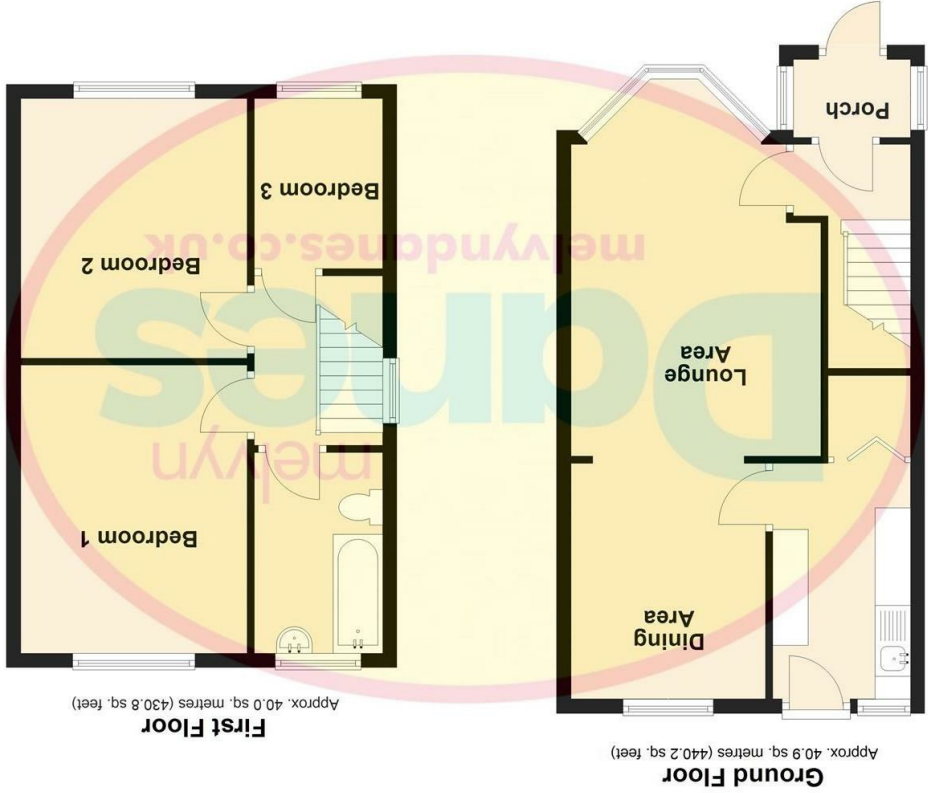
