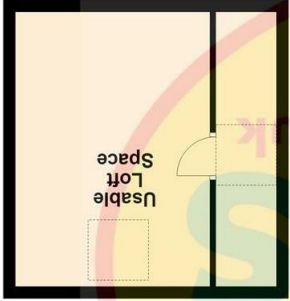
Ground Floor

Approx. 41.1 sq. metres (442.2 sq. feet)

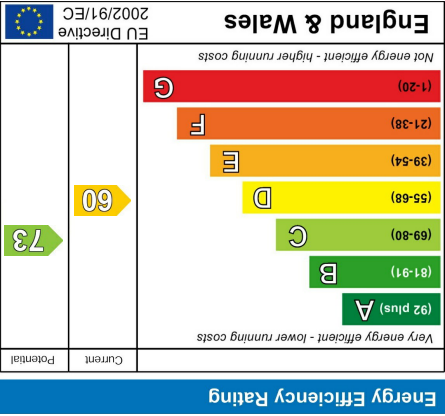


Second Floor
