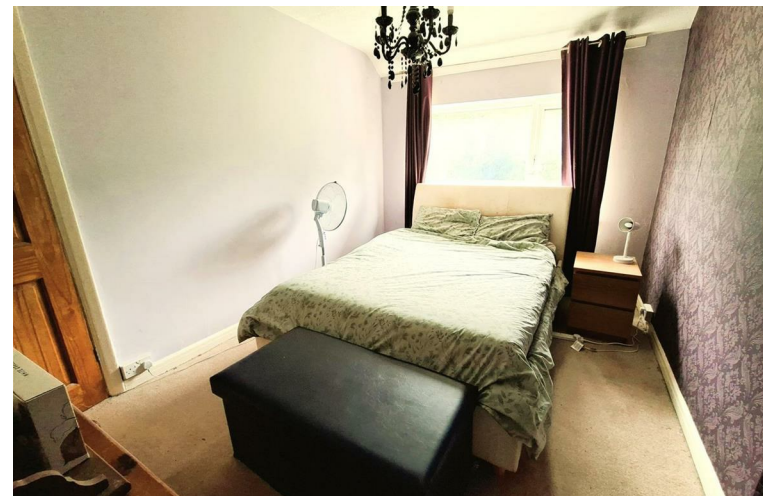
A spacious mid terraced house on a popular and convenient road in Acocks Green with NO ONWARD CHAIN and HUGE scope to extend (STPP).

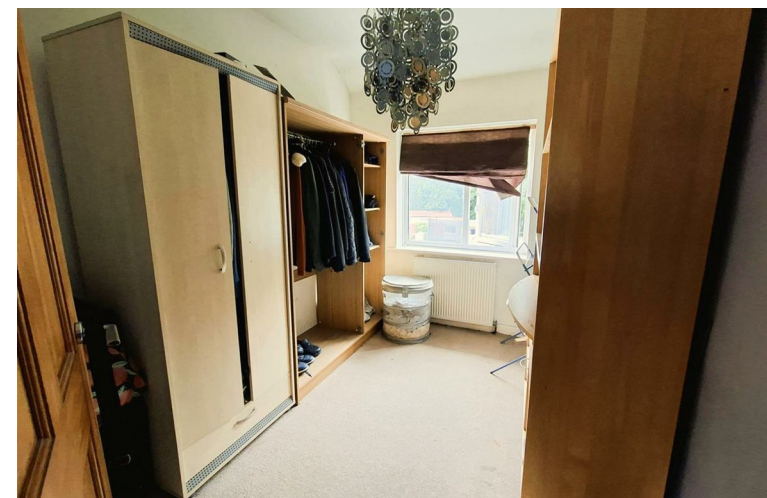

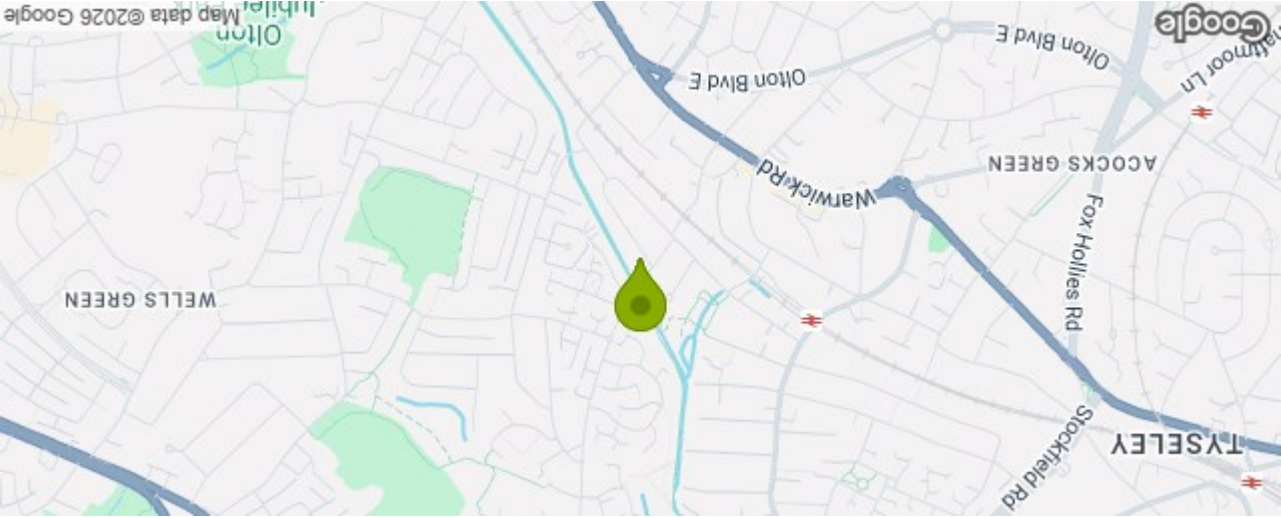
